# OXFORDSHIRE COUNTY COUNCIL (CENTRAL AREA, OXFORD) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) (VARIATION NO.8) ORDER 2016

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 32, 35, 45 and 46 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act hereby make the following Order:

- 1. This Order may be cited as the Oxfordshire County Council (Oxford Central Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.8) Order 2016 and shall come into operation on the 11<sup>th</sup> day of January 2016.
- 2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
  - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
- 3. The Oxfordshire County Council (Central Area, Oxford) (Controlled Parking Zone) Order 2011, as amended by the Oxfordshire County Council (Central Area, Oxford) (Controlled Parking Zone) (Variation No.1) Order 2012, the Oxfordshire County Council (Central Area, Oxford) (Controlled Parking Zone) (Variation No.2) Order 2013, the Oxfordshire County Council (Central Area, Oxford) (Controlled Parking Zone) (Variation No.) Order 2013, the Oxfordshire County Council (Central Area, Oxford) (Controlled Parking Zone) (Variation No.4) Order 2014, the Oxfordshire County Council (Central Area, Oxford) (Controlled Parking Zone) (Variation No.5) Order 2015, the Oxfordshire County Council (Central Area, Oxford) (Controlled Parking Zone) (Variation No.6) Order 2015 and the Oxfordshire County Council (Central Area, Oxford) (Controlled Parking Zone) (Variation No.7) Order 2015 ("the 2011 Order") is amended in the manner and to the extent specified in the Schedule to this Order.

#### **SCHEDULE**

Amendments to the 2011 Order:

1.)

The Index is amended to extend Schedule 8 as follows:

#### SCHEDULE 8 – VEHICLE LOADING BAYS

"PART G – (Between 8.00am and 6.30pm on every day)
Thirty minute stay (No return within one hour)"

2.)

The below Definition is deleted and replaced as follows:

"Prescribed Hours" means:

- (a) in relation to any length of road specified in Schedule 4 and Part G of Schedule 8 between 8.00am and 6.30pm on every day of the week:
- (b) in relation to any length of road specified in Part B of Schedule5, in Schedule 6 or Schedule 7, in Parts A, C and D of Schedule8 or in Schedule 9 and Schedule 10, the whole 24 hours of every day;
- (c) in relation to any length of road specified in Parts B and E of Schedule 8 between 6.00am and 6.30pm on every day of the week:
- (d) in relation to any length of road specified in Part F of Schedule 8 from midnight to 10.00am and 6.00pm to midnight on every day of the week."
- **3.)** Article 57 (2) is deleted and replaced as follows:

### PART XII VEHICLE LOADING BAYS

#### **Designation of Vehicle Loading Bay**

"57. (2) Each of the lengths of road specified in Parts C, D, E and G of Schedule 8 to this Order is authorised to be used, subject to the provisions of this Order, during the Prescribed Hours as a Parking Place for any vehicle for the purpose of being loaded or unloaded in connection with any trade or business situated in a road specified in Schedule 1 to this Order". In Schedule 2 Part E, a new road is added alphabetically as follows:

#### SCHEDULE 2 "PART E

## LOADING AND UNLOADING RESTRICTIONS (Between 8.00 a.m. and 6.30 p.m. on every day of the week)

"Pembroke Street

(a) Southern side:

from its junction with St Ebbes, eastwards to its junction with St Aldates

- (b) Northern side;
  - (i) From the junction with St Ebbes, eastwards for 62 metres:
  - (ii) From the junction with St Aldates, westwards for 90 metres."

5.)

In Schedule 8 a new Part G is added as follows:

#### SCHEDULE 8 VEHICLE LOADING BAYS "PART G

Between 8.00am and 6.30pm on every day of the week 30 minute stay, no return within 1 hour

LENGTHS OF ROAD IN THE CITY OF OXFORD

Pembroke Street

From the western boundary of No.39, westwards for 11.5 metres"
