

**THE OXFORDSHIRE COUNTY COUNCIL
(MINCHERY FARM) (OXFORD) (CONTROLLED PARKING ZONE)
(VARIATION No.5) ORDER 2016**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1) and 2(1) & (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Minchery Farm) (Oxford) (Controlled Parking Zone) (Variation No.5) Order 2016 and shall come into operation on the ninth day of February 2016.
2. In this Order, except where the context otherwise requires, the following expressions have the following meanings:
 - (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
 - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.

3. The Oxfordshire County Council (Minchery Farm) (Oxford) (Controlled Parking Zone) Order 2005; as amended by the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) Order 2007, the Oxfordshire County Council (Blackbird Leys West, Minchery Farm, Frys Hill and Brake Hill, Oxford) (Controlled Parking Zone) (Variation) Order 2007; the Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 – Consequential Provisions) Order 2008, and the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) Order 2010 ("the 2005 Order") is further amended in the manner and to the extent specified in the Schedule to this Order.
