

**OXFORDSHIRE COUNTY COUNCIL
(HEADINGTON NORTHEAST) (CONTROLLED PARKING ZONE
AND WAITING RESTRICTIONS) (VARIATION NO.11) ORDER 2016**


The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, makes the following Order.

1. This Order may be cited as the Oxfordshire County (Headington North East) (Controlled Parking Zone and Waiting Restrictions) (Variation No.11) Order 2016 and shall come into operation on the 14th day of March 2016.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.

(2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.

(3) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.

(4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.

The Oxfordshire County Council(Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) Order 2006 as amended by the Oxfordshire County Council (Headington Quarry, Girdlestone Road, Headington and Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) Order 2007; the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2008, the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.3) Order 2003, the Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2002 - Consequential Provisions) Order 2008 and the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.5) Order 2008 the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.6) Order 2009, the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.7) Order 2009, the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.8) Order 2010, and the Oxfordshire County Council (Headington Northeast) (Controlled Parking Zone and Waiting Restrictions) (Variation No.9) Order 2011, ("the 2006 Order") is amended in the manner and to the extent specified in the Schedule to this Order.

- (k) East side: from a point 8 metres north of the common boundary of numbers 21a and 21b Wharton Road, northwards for a distance of 8 metres.
- (l) East side: from a point 3 metres north of the common boundary of numbers 25 and 27 Wharton Road, northwards for a distance of 11 metres.
- (m) East side: from a point 4 metres north of the common boundary of 59 and 61 Wharton Road, southwards for a distance of 8 metres.
- (n) East side: from a point 4 metres north of the common boundary of numbers 63 and 65 Wharton Road, southwards for a distance of 5 metres.

There are excluded from the above lengths of road any Disabled Persons' Parking Places."
