# OXFORDSHIRE COUNTY COUNCIL (BLACKBIRD LEYS WEST) (OXFORD) (CONTROLLED PARKING ZONE) (VARIATION No.8) ORDER 2016

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 45 and 46 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order:

- 1. This Order may be cited as the Oxfordshire County Council (Blackbird Leys West) (Oxford) (Controlled Parking Zone) (Variation No.8) Order 2016 and shall come into force on the 18<sup>th</sup> day of August 2016.
- 2. In this Order, except where the context otherwise requires, the following expressions have the following meanings:
  - (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa

(Controlled Parking Zone) Order 2005, as amended by The Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 - Consequential Provisions) Order 2008; the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) 2007; the Oxfordshire County Council (Blackbird Leys West, Minchery Farm, Frys Hill and Brake Hill, Oxford) (Controlled Parking Zone) (Variation) Order 2007; the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) 2010; the Oxfordshire County Council (Oxford - Car Club Parking Places) Order 2010; the Oxfordshire County Council (City of Oxford and North Hinksey) (Variation of Charges for Permits) Order 2016; and the Oxfordshire County Council (City of Oxford) (Modification of Renewal Mechanism for Residents Permits and Visitors Permits) Order 2016, is amended in the manner and to the extent specified in the Schedule to this Order
