OXFORDSHIRE COUNTY COUNCIL (NORHAM MANOR, OXFORD) (CONTROLLED PARKING ZONE) (VARIATION No.11) ORDER 2016

The Oxfordshire County Council ("the Council") in exercise of their powers under Sections 32, 35, 45 and 46 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, make the following Order:

- 1. This Order may be cited as the Oxfordshire County Council (Norham Manor, Oxford) (Controlled Parking Zone) (Variation No.11) Order 2016 and shall come into operation on the 12th day of December 2016.
- 2. In this Order, except where the context otherwise requires, the following expressions have the following meanings:
 - (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment;
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa;
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
- The City of Oxford (Norham Manor) (Controlled Parking Zone) Order 1999 ("the 3. 1999 Order") as amended by The City of Oxford (Norham Manor) (Controlled Parking Zone) (Variation No.1) Order 2000, The Oxfordshire County Council (Norham Manor, Oxford) (Controlled Parking Zone) (Variation No.2) Order 2007, The Oxfordshire County Council (Disabled Persons Parking Places - Oxford) Order 2007 and the Oxfordshire County Council (City of Oxford and North Hinksey) (Traffic Management Act 2004 - Consequential Provisions) Order 2008, The Oxfordshire County Council (Norham Manor, Oxford) (Controlled Parking Zone) (Variation No.5) Order 2009, the Oxfordshire County Council (City of Oxford) (Variation of Charges for Residents Permits) Order 2010, the Oxfordshire County Council (Norham Manor, Oxford) (Controlled Parking Zone) (Variation No.7) Order 2012, and the Oxfordshire County Council (Norham Manor, Oxford) (Controlled Parking Zone) (Variation No.8) Order 2014, The Oxfordshire County Council (City of Oxford and North Hinksey) (Variation of Charges for Permits) Order 2016, and the Oxfordshire County Council (City of Oxford) (Modification of Renewal Mechanism for Residents Permits and Visitors Permits) Order 2016 ("the 1999 Order") is amended in the manner and to the extent specified in the Schedule to this Order.
