

**OXFORDSHIRE COUNTY COUNCIL  
(LAKE STREET AND VICARAGE ROAD AREA) (TRAFFIC MANAGEMENT  
AND PARKING) (CONSOLIDATION) (VARIATION No.3) ORDER 2016**

The Oxfordshire County Council ("the Council") in exercise of its powers contained in Sections 1, 2, 4, 32, 35 & 45 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order:

1. This Order may be cited as The Oxfordshire County Council (Lake Street and Vicarage Road Area) (Traffic Management and Parking) (Consolidation) (Variation No.3) Order 2016 and shall come into force on the 12<sup>th</sup> day of December 2016.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment  
(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa  
(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
3. The Oxford City Council (Lake Street and Vicarage Road Area) (Traffic Management and Parking) (Consolidation) Order 1997, as amended by the Oxfordshire County Council (Disabled Persons Parking Places - Oxford) Order 2002, and The Oxfordshire County Council (Oxford – Car Club Parking Places) Order 2012 ("the 1997 Order") shall be amended in the manner and to the extent specified in the Schedule to this Order.

## **SCHEDULE**

### **Amendment to the articles:**

#### **(1).**

In article 3 Definitions – the following is deleted and replaced:

“Restricted hours means:

(i) in relation to any restricted road specified in Schedule 2 this order the whole of 24 hours of every day

(ii) in relation to any restricted road specified in Schedule 4 this order the period between 8am and 6pm Monday to Friday inclusive.”

#### **(2).**

In article 7 (Part III) of the order, the first line is amended to include the words “and Schedule 4” after the words “Schedule 3”

#### **(3).**

Part IV of the order and articles 15 to 17 are deleted entirely.

A new Part IV is added as follows:

### **“PART IV**

#### **ONE HOUR PARKING PLACE – MONDAY TO FRIDAY – 8am to 6pm**

#### **NO RETURN WITHIN 2 HOURS**

15. Save as provided in article 6 of this order, no person shall, other than with the consent or permission of a police constable in uniform, a parking attendant, or the Council, cause or permit a vehicle wait in the length of road specified in Schedule 4 to this order:

- (a) for a period longer than one hour; or
- (b) if a period of less than two hours has elapsed since the termination during the Prescribed Hours of the last period of parking of the vehicle in the same Parking Place.”

16. Where a vehicle, having been left in a parking place, remains there at the beginning of the Restricted Hours, then the vehicle will be treated for the purposes of Article 15 as if it had arrived in the parking place at the beginning of the Restricted Hours.”

#### **(4).**

Item 3 (b) of Schedule 3 is deleted and replaced as follows:

(b) Northern side, from a point 199 metres west of the western kerb line of Abingdon Road, westwards to a point 2 metres east of the eastern face wall of the Health Centre."
