OXFORDSHIRE COUNTY COUNCIL (CITY OF OXFORD) (JERICHO) (PARKING PLACES AND CONTROLLED PARKING ZONE) (VARIATION NO.25) ORDER 2018

The Oxfordshire County Council, in exercise of its powers under Sections 1, 2, 4, 32, 35, 45 and 46 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

- 1. This Order may be cited as the Oxfordshire County Council (City of Oxford) (Jericho) (Parking Places and Controlled Parking Zone) (Variation No.25) Order 2018 and shall come into force on the 23rd day of July 2018.
- 2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
 - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.

"<u>Part XII</u> VEHICLE LOADING BAYS

Loading Bays

The length of road specified in Schedule 11 is authorised to be used, subject to the following provisions, during the prescribed hours as a vehicle loading bay for goods vehicles, light goods vehicles, passenger vehicles and dual purpose vehicles which are waiting in the said vehicle loading bay for the purpose of being loaded or unloaded in connection with any trade or business situated in that road.

Restriction on Waiting – Position

No person is to cause or permit a vehicle to wait in a Loading Bay unless it is parked with every part of the vehicle on the carriageway so that it is entirely within the limits of the Loading Bay as marked unless an exemption as specified in Article 6 (c) & (d), and (f) to (i) applies, and for a Motor Cycle it is also parked so that it is perpendicular to the kerb."
