

**OXFORDSHIRE COUNTY COUNCIL
(NORTH OXFORD)
(CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS)
(VARIATION No.15) ORDER 2018**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) & (2), 4, 32, 35, 45 & 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

1. This Order may be cited as the Oxfordshire County Council (North Oxford) (Controlled Parking Zone and Waiting Restrictions) (Variation No.15) Order 2018 and shall come into operation on the first day of October 2018.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.

(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.

(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.

(4) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to a numbered Article or Schedule bearing that number in this Order.

No.13) Order 2018, and the Oxfordshire County Council (Oxford Electric Vehicle Parking Places) Order 2018, ("the 2004 Order") is amended in the manner and to the extent specified in the Schedule to this Order.

Banbury Road`

Both sides from the common property boundary of Diamond Court and 157 Banbury Road, to both sides of St Margaret's Road northern highway boundary.

Bardwell Road
Belbroughton Road
Chadlington Road
Chalfont Road
Charlbury Road
Cunliffe Close
Frenchay Road

Both sides, from its junction with Woodstock Road, westwards to the eastern side of Oxford Canal.

Garford Road
Hayfield Road

From its point of closure 46 metres north of the northern side of Polstead Road, northwards to Frenchay Road.

Lathbury Road
Linton Road
Moreton Road
Northmoor Road
Rawlinson Road
Staverton Road
Woodstock Road

Both sides between the common property boundaries of Nos. 251 and 253 Woodstock Road and the southern kerb line of Beechcroft Road to both sides of the common property boundary of No 86 Woodstock Road and Hartley Court."

(3).

The title of Part A of Schedule 3 is amended to read as follows:
