

**TRAFFIC MANAGEMENT ACT 2004
OXFORDSHIRE COUNTY COUNCIL
NOTICE OF LEVEL OF PENALTY CHARGE NOTICES
FOR PARKING CONTRAVENTIONS**

NOTICE IS HEREBY GIVEN THAT Oxfordshire County Council in accordance with Schedule 9 of the Traffic Management Act 2004 as amended ("the Act") intends, with effect of **1st November 2021**, to set the level of penalty charges for parking contraventions within new areas designated as a Special Enforcement Areas (SEAs) in the Districts of Cherwell, Vale of White Horse and South Oxfordshire, as set out in the Schedule below.

Schedule:

Code	Description	Level	Penalty
1	Parked in a restricted street during prescribed hours	HIGH	£70
2	Parked or loading/unloading in a restricted street where waiting and loading/unloading restrictions are in force	HIGH	£70
5	Parked after the expiry of paid for time	LOW	£50
6	Parked without clearly displaying a valid pay & display ticket or voucher	LOW	£50
7	Parked with payment made to extend the stay beyond initial time	LOW	£50
12	Parked in a residents' or shared use parking place without clearly displaying either a permit or voucher or pay and display ticket issued for that place	HIGH	£70
14	Parked in an electric vehicles' charging place during restricted hours without charging	HIGH	£70
16	Parked in a permit space without displaying a valid permit	HIGH	£70
19	Parked in a residents' or shared use parking place or zone either displaying an invalid permit or voucher or pay and display ticket, or after the expiry of paid for time	LOW	£50
21	Parked in a suspended bay/space or part of bay/space	HIGH	£70
22	Re-parked in the same parking place or zone within the prescribed time period after leaving	LOW	£50

Code	Description	Level	Penalty
23	Parked in a parking place or area not designated for that class of vehicle	HIGH	£70
24	Not parked correctly within the markings of the bay or space.	LOW	£50
25	Parked in a loading place during restricted hours without loading.	HIGH	£70
26	Parked in a special enforcement area more than 50 centimetres from the edge of the carriageway and not within a designated parking place	HIGH	£70
30	Parked for longer than permitted.	LOW	£50
40	Parked in a designated disabled person's parking place without clearly displaying a valid disabled person's badge	HIGH	£70
45	Parked on a taxi rank	HIGH	£70
46	Stopped where prohibited (on a red route or clearway)	HIGH	£70
47	Stopped on a restricted bus stop or stand	HIGH	£70
49	Parked wholly or partly on a cycle track or lane	HIGH	£70
99	Stopped on a pedestrian crossing and/or crossing area marked by zig-zags	HIGH	£70

If the Penalty Charge Notice (PCN) is paid not later than the last day of the period of 14 Days, beginning with the date on which the PCN was served, the PCN will be discounted by 50% to £25/£35.

The PCN will be incremented by 50% to £75/£105 on issue of a Charge Certificate, i.e. after no representations or payment have been made within the period of 28 days beginning with the date on which the PCN is served.

Following rejection of an informal appeal, the Council will offer a further 14 days for the payment of a PCN at the discounted rate of £25/£35 if the informal appeal was received within the 14 day discounted period
