OXFORDSHIRE COUNTY COUNCIL (OXFORD, MAGADALEN ROAD SOUTH AREA) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) (VARIATION No.1) ORDER 2021

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

- This Order may be cited as the Oxfordshire County Council (Oxfordshire County Council (Oxford - Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) Order (Variation No.1) Order 2021 and shall come into force on the sixth day of December 2021.
- 2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
 - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.
- The Oxfordshire County Council (Oxford Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) Order 2019 ("the 2021 Order") is amended in the manner and to the extent specified in the Schedule to this Order.

- b) North east side: from the boundary between Nos. 29 and 31 Essex Street north westwards to a point 1 metre south east of the boundary between Nos. 19 and 21 Essex Street.
- c) North east side: from a point 1 metre north west of the boundary between Nos. 19 and 21 Essex Street north westwards to the north west flank wall of No. 13 Essex Street.
- d) North east side: from the south east flank wall of No. 9 Essex Street north westwards to the north west flank wall of No. 1 Essex Street.
- 5 Golden Road
- a) South west side: from a point 6 metres north west of its junction with Howard Street north westwards for a distance of 18 metres
- b) South west side: from a point opposite to the boundary between Nos. 30 and 32 Golden Road north westwards for a distance of 16 metres.

- c) North east side: from the boundary between Nos. 34 and 36 Golden Road south eastwards to the south east flank wall of No. 2 Golden Road.
- d) North east side: from a point 6 metres south east of the south east flank wall of No. 2 Golden Road south eastwards for a distance of 11 metres.
- 6 Hertford Street a) North east side: from the boundary between Nos. 63 and 65 Hertford Street north westwards to a point opposite the boundary between Nos. 38a and 40 Hertford Street.
- 7 Percy Street a) North west side: from the south west flank wall of No. 105 Percy Street north eastwards to the boundary between Nos. 92 and 93 Percy Street.
 - b) North west side: from the boundary between Nos. 88 and 90 Percy Street north eastwards to a point 2 metres south west of the boundary between Nos. 76 and 77 Percy Street.
 - c) North west side: from a point 1 metre south west of the south west flank wall of No. 69
 Percy Street north eastwards to the north east flank wall of No. 61 Percy Street.
 - d) North west side: from a point 4 metres north east of the north east flank wall of No. 60 Percy Street north eastwards for a distance of 26 metres.
 - e) South east side: from a point 1.5 metres south west of the south west flank wall of No. 38a
 Percy Street south westwards to a point 7

- 9 Silver Road a) North east side: from a point opposite the boundary between Nos. 17 and 18 Silver Road south eastwards to a point 15 metres south east of the south east flank wall of No. 35 Silver Road.

There are excluded from the above lengths of road any Disabled Persons' Parking Place, any Car Club Parking Places, Electric Vehicle Parking Place, any Controlled Length and any area where stands or racks or the like have been provided by the Council for cycle parking for so long as they remain in place."
