## OXFORDSHIRE COUNTY COUNCIL (VARIOUS STREETS, OXFORD) (WAITING AND LOADING RESTRICTIONS) CONSOLIDATION (VARIATION No.24) ORDER 2022

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1 (1), 2 (1) & (2) and 4, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.
