

**OXFORDSHIRE COUNTY COUNCIL
(OXFORD) (LYE VALLEY AREA) (RESTRICTED PARKING ZONE AND
WAITING RESTRICTIONS) (VARIATION No.4) ORDER 2022**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

1. This Order may be cited as The Oxfordshire County Council (Oxford) (Restricted Parking Zone and Waiting Restrictions) (Variation No.4) Order 2022 shall come into force on the 11th day of April 2022.
2.
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
 - (4) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
 - (5) Any reference in this Order to a numbered Article shall unless the context otherwise requires be construed as a reference to the numbered Article bearing that number in this Order.

The Oxfordshire County Council (Oxford) (Lye Valley) (Restricted Parking Zone and Waiting Restrictions) Order 2016, as amended by The Oxfordshire County Council (Oxford) (Lye Valley) (Restricted Parking Zone and Waiting Restrictions) (Variation No.1) Order 2019, and the Oxfordshire County Council (City of Oxford and North Hinksey) (Variation of Charges for Permits) Order 2020, the Oxfordshire County Council (Oxford) (Lye Valley) (Restricted Parking Zone and Waiting Restrictions) (Variation No.2) Order 2020, and the Oxfordshire County Council (City of Oxford) (Modification of Renewal Mechanism for Residents Permits and Visitors Permits) Order 2021 Order 2020 ("the 2016 Order") is amended in the manner and to the extent specified in the schedule to this order.
