

**OXFORDSHIRE COUNTY COUNCIL
(OXFORD, EAST OXFORD AREA)
(LOW TRAFFIC NEIGHBOURHOODS EXPERIMENTAL TRAFFIC
MANAGEMENT) ORDER 2022**

Oxfordshire County Council ("the Council") in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Oxford, East Oxford Area) (Experimental Traffic Management) Order 2022 and shall come into force on the 20th day of May 2022.
2. (1) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment

(2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment

(3) Any reference in this Order to a numbered Article shall unless the context otherwise requires be construed as a reference to the numbered Article bearing that number in this Order.
3. The Director for Environment and Place (or person so nominated) of the Council is empowered to modify or suspend this Order or any provision of it pursuant to and in accordance with Section 10(2) of the Act.

Orders affected

4. If the provisions of this experimental order are made permanent, the measures specified herein, as appropriate, may be added to the following base orders by way of amendments:
 - (1) The Oxfordshire County Council (Oxford - Magdalen Road North Area) (Controlled Parking Zone and Waiting Restrictions) Order 2012 (as amended)
 - (2) The Oxfordshire County Council (Oxford - Divinity Road Area) (Controlled Parking Zone and Waiting Restrictions) Order 2012 (as amended)
 - (3) The Oxfordshire County Council (East Oxford) (Controlled Parking Zone Waiting Restrictions and Traffic Management) Order 2010 (as amended)
 - (4) The Oxfordshire County Council (Oxford - Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) Order 2019 (as amended)
 - (5) The Oxfordshire County Council (Parking Places for Pedal Cycles, Oxford) Consolidation (Variation) Order 2009 (as amended).

(6) The Oxfordshire County Council (Oxford Area -Various Streets) (Traffic Management) Order 2022

(7) The Oxfordshire County Council (Oxford – Cowley Marsh Area) (Controlled Parking Zone and Waiting Restrictions) Order 2020 (as amended)

PROHIBITION OF WAITING

5. The orders specified in article 4 (2) to (6) of this order are temporarily amended in accordance with Schedule 1 of this order.

TRAFFIC FILTERS – PROHIBITION OF MOTOR VEHICLES

6. Save as provided in Article 7 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle being driven in the road specified in column 1 of Schedule 2 of this order, to proceed through the point specified in column 2 of said schedule.

EXEMPTIONS

7. (1) Nothing in Article 6 shall apply to a vehicle proceeding contrary to the restriction, only as may be necessary if the vehicle is being used:
- a) by a vehicle being used for Police, Fire or Ambulance services;
 - b) for removing any obstruction to traffic at or adjoining that road;
 - c) for undertaking works (including inspection) in relation to that road or to a traffic sign, street lighting or street furniture at or adjoining that road;
 - d) for undertaking works (including inspection) in relation to a sewer or water main, the supply of gas, electricity or communication services in or adjoining that road;
 - e) for statutory services by or for the Council or Oxford City Council for street cleaning or the collection of waste;
 - f) by the holder of a key provided by the Council for use by that person, which permits access through a traffic filter / gate / bollards closure point.

One-Way Streets

8. The relevant parts of the order specified in article 4 (5) of this order is temporarily amended / suspended as specified in Schedule 3 to this order.

Prescribed Routes

9. The relevant parts of the order specified in article 4 (5) of this order is temporarily amended / suspended as specified in Schedule 4 to this order.

Prohibition of Entry

10. The relevant parts of the order specified in article 4 (5) of this order is temporarily amended as specified in Schedule 5 to this order.

Residents Permit Holder Parking

11. (1) Residents of local Controlled Parking Zones (CPZs) are permitted by the Council to use neighbouring permit parking areas, such that residents of Magdalen North CPZ may park in the Magdalen South CPZ area, and vice versa; also residents of Magdalen South CPZ may park in Cowley Marsh CPZ and vice versa.
- (a) The Oxfordshire County Council (Oxford - Magdalen Road North Area) (Controlled Parking Zone and Waiting Restrictions) Order 2012 (as amended)
 - (b) The Oxfordshire County Council (Oxford - Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) Order 2019 (as amended)
 - (c) The Oxfordshire County Council (Oxford – Cowley Marsh Area) (Controlled Parking Zone and Waiting Restrictions) Order 2020 (as amended)
- (2) The holders of residents parking permits specified in Schedule 5 Part A of the order specified in article 10 (a) above North are temporarily permitted to park, whilst displaying a valid residents parking permit, in the lengths of road specified in Schedules 4 Part C, E, F, G, H & I, and Schedule 5 Parts B & C of the order specified in article 10 (b) above
- (3) The holders of residents parking permits specified in Schedule 5 Part A of the order specified in article 10 (b) above south are temporarily permitted to park, whilst displaying a valid residents parking permit, in the lengths of road specified in:
- (a) Schedule 4 Part C, D, E & F and Schedule 5 Parts B & C of the order specified in article 10 (a) above,
 - (b) Schedules 4 & 5 of the order specified in article 10 (c) above ,
- (4) The holders of residents parking permits specified in Schedule 3 of the order specified in article 10 (c) above Marsh are temporarily permitted to park, whilst displaying a valid residents parking permit, in the lengths of road specified in Schedules 4 Part C, E, F, G, H & I, and Schedule 5 Parts B & C of the order specified in article 10 (b) above.
12. This Order shall continue in operation for a period of no more than 18 months from the date on which it comes into force.


