

**THE OXFORDSHIRE COUNTY COUNCIL  
(OXFORD - DIVINITY ROAD AREA)  
(CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS)  
(VARIATION No.12) ORDER 2022**

The Oxfordshire County Council in exercise of its powers under Sections 1, 2, 4, 32, 35, 45 and 46 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Oxford – Divinity Road Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.12) Order 2022 and shall come into force on the 25<sup>th</sup> day of July 2022.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment  
  
(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.  
  
(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment  
  
(4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.

2022 ("the 2012 Order") is amended in the manner and to the extent specified in the Schedule to this Order.

| 3 Southfield Park | a) North west side: from a point 3 metres north east of the north east flank wall of flat Nos. 123 to 153 Southfield Park south westwards for a distance of 37 metres.<br>b) North west side: from a point 1.5 metres   |

south east of the north east flank wall of flat Nos. 91 to 121 Southfield Park south westwards for a distance of 18 metres.

c) North west side: from a point 5.5 metres north east of the north east flank wall of flat Nos. 31 to 57 Southfield Park south westwards for a distance of 17.5 metres.

d) South east side: from a point 2.5 metres north east of the north east flank wall of flat Nos. 192 to 222 Southfield Park north eastwards to a point opposite 3 metres north east of the north east flank wall of flat Nos. 123 to 153.

Perpendicular to the kerb

e) South east side: from a point 1 metre south west of the north east flank wall of flat Nos. 192 to 222 Southfield Park south westwards for a distance of 13 metres.

f) North east side: from a point 5 metres south east of the north west flank wall of flat Nos. 192 to 222 Southfield Park south eastwards for a distance of 33 metres.

There are excluded from the above lengths of road any Disabled Persons' Parking Places or Car Club Parking Places"
