THE OXFORDSHIRE COUNTY COUNCIL (EAST OXFORD) (CONTROLLED PARKING ZONE, WAITING RESTRICTIONS AND TRAFFIC MANAGEMENT) (VARIATION No.36) ORDER 2022

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2 (1) & (2), 32, 35, 45 & 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

- 1. This Order may be cited as the Oxfordshire County Council (East Oxford) (Controlled Parking Zone, Waiting Restrictions and Traffic Management) (Variation No.36) Order 2022 and shall come into force on 25th day of July 2022.

Amendment to "the 2010 Order".

1.)

The following Definition is added alphabetically:

"E-Scooter" means a motor vehicle which-

- (a) is fitted with an electric motor with a maximum continuous power rating not exceeding 500 watts;
- (b) is not fitted with pedals that are capable of propelling the vehicle;
- (c) has two wheels, one front and one rear, aligned along the direction of travel;
- (d) is designed to carry no more than one person;
- (e) has a maximum weight, excluding the driver, not exceeding 55 kilograms;
- (f) has a maximum design speed not exceeding 15.5 miles per hour;
- (g) has a means of directional control through the use of handlebars which are mechanically linked to the steered wheel;
- (h) has a means of controlling the speed through hand controls; and
- (i) has a power control that defaults to the 'off' position.

Part XVI Prohibition of Driving

In article 62 – Exemptions - item (1) 'Pedal Cycle' shall be replaced with 'Pedal Cycle or E-Scooter'


Part XVIII Mandatory Cycle Lanes
