

**OXFORDSHIRE COUNTY COUNCIL  
(WALTON MANOR, OXFORD) (PARKING PLACES AND TRAFFIC  
MANAGEMENT) (CONSOLIDATION) (VARIATION No.26) ORDER 2022**

The Oxfordshire County Council ("the Council") in exercise of their powers under Sections 1(1), 2(1) & (2), 4(2), 32, 35, 45, 46 & 63 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Walton Manor, Oxford) (Parking Places and Traffic Management) (Consolidation) (Variation No.26) Order 2022 and shall come into force on the tenth day of October 2022.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment  
  
(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa  
  
(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment

4. The Oxfordshire County Council (Oxford, North Parade Avenue) (Experimental Traffic Management) Order 2021 is hereby revoked.

### **SCHEDULE**

Amendments to "the 2003 Order":

1.)

In article 3 - Definitions, the following shall be added to the end of "Restricted Hours":

"in relation to North Parade Avenue (Schedule 12 of this order) on all days

- a) from November to March inclusive the hours between 10.00am and 6.30pm, and
- b) from April to October inclusive the hours between 10.00am and 9.00pm Friday and Saturday."

2.)

New articles are inserted as follows:

### **PROHIBITION OF ENTRY**

"68A Save as save as provided by article 68B no vehicle being driven in a road specified in column 1 of Part C of Schedule 9 to this order shall during Restricted Hours be driven into the road specified opposite to it in column 2 of said Schedule.

68B Nothing in article 68A shall make it unlawful for a vehicle to enter the specified roads for any of the following purposes:

- 1) vehicles of the Police, Fire or Ambulance services;
- 2) for a vehicle requiring access to / from Nos. 75B, 75C and 77 Banbury Road - from its junction with Banbury Road westwards for 50 metres
- 3) for a vehicle requiring access to / from Nos. 15 and 16 Winchester Road - from its junction with Winchester Road eastwards for 42 metres;
- 4) a Cycle."

3.)

New articles and heading are inserted as follows:-

### **"PROHIBITION OF VEHICLES**

69A. Save as provided by article 69B of this order, no vehicle shall be driven or ridden during Restricted Hours in the length of road specified in Schedule 12.

69B. Nothing in article 69A shall make it unlawful for a vehicle to enter the specified road during Restricted Hours for any of the following purposes:

- 1) vehicle of the Police, Fire or Ambulance services in an emergency;
- 2) for a vehicle requiring access to / from Nos.15 and 16 Winchester Road - from its junction with Winchester Road eastwards for 42 metres;
- 3) cycle not being ridden."

A new Schedule 12 is inserted as follows:

**"SCHEDULE 12  
PROHIBITION OF VEHICLES**

(between 10.00am and 6.30pm Sunday to Thursday, and  
between 10.00am and 7.30pm Friday and Saturday)

North Parade Avenue from a point 50 metres west of its junction with  
Banbury Road, to a point 10 metres east of its junction  
with Winchester Road."
