

**OXFORDSHIRE COUNTY COUNCIL  
(OXFORD AREA - VARIOUS STREETS)  
(TRAFFIC MANAGEMENT) (VARIATION No.5) ORDER 2022**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Oxford Area - Various Streets) (Traffic Management) (Variation No.5) Order 2022 and shall come into force on the 31<sup>st</sup> day of October 2022.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.  
  
(2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.  
  
(3) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to a numbered Article or Schedule bearing that number in this Order.

The Oxfordshire County Council (Oxford - Various Streets) (Traffic Management) Order 2022) Order 2022, as amended by the Oxfordshire County Council (Oxford Area - Various Streets) (Traffic Management) (Variation No.1) Order 2022, the Oxfordshire County Council (Oxford Area - Various Streets) (Traffic Management) (Variation No.2) Order 2022, the Oxfordshire County Council (Oxford Area - Various Streets) (Traffic Management) (Variation No.3) Order 2022, and the Oxfordshire County Council (Oxford Area -Various Streets) (Traffic Management) (Variation No.4) Order 2022 ("the 2022 Order") is amended in the manner and to the extent specified in the Schedule to this order.

Collins Street	From its junction with Union Street to its junction with Chapel Street
Collins Street	From a point 18 metres northwest of the north-western kerb line of East Avenue, north westwards for a distance of 1 metre
Crescent Road	At a point 30 metres west of the junction with Junction Road

East Avenue	From a point 59.4 metres north east of the rear of the north eastern footway of Cowley Road north-eastwards for a distance of 1 metre
Fox Crescent (New Hinksey)	(a) The main carriageway, from a point 6 metres south of the southern kerb line of Chatham Road, southwards for 4 metres
	(b) The crescent of Fox Crescent, from a point 9 metres south of the boundary of Nos.18 & 20 Fox Crescent, southwards for 1.5 metres
Freelands Road	(i) That part between Iffley Road and Radcliffe Road, westwards into that part between Donnington Bridge Road and Radcliffe Road
	(ii) That part between Donnington Bridge Road and Radcliffe Road, eastwards into that part between Iffley Road and Radcliffe Road
	(iii) That part between Iffley Road and Radcliffe Road into Radcliffe Road
Gipsy Lane	Grays Road
Grays Road	Gipsy Lane
Hayfield Road (North Oxford)	From a point 47 metres north of the northern kerb line of Polstead Road, northwards for 1.5 metres
Headington Road	Cheney Lane
Iffley Road	West side of the central island, from a point 5 metres north of its junction with Cavell Road, northwards to the southern kerb line of the private access serving No.370 Iffley Road, a distance of 53 metres.
Liddell Road	at a point 14 metres north of junction with Dodgson Road.
Littlehay Road	At a point 15 metres east of the junction with Rymers Lane
Littlemore Road	at a point 10 metres north of junction with Compass Close.
Marsh Lane	Brookfield Crescent
Mayfair Road	at a point 25 metres west of junction with Littlemore Road.
Meadow Lane (southern end)	From a point 32 metres south of the southern kerb line of Fairacres Road, southwards for 5 metres
Oxford Road	Clive Road
Phipps Road	from a point 5 metres northeast of the northeast kerb line of Bailey Road to a point 6 metres northeast of the northeast kerb line of Bailey Road
Phipps Road	from a point 6 metres northeast of the northeast kerb line of Bailey Road to a point 7 metres northeast of the northeast kerb line of Bailey Road

Radcliffe Road	From Radcliffe Road, westwards into Freelands Road
Rymers Lane	A point 213 metres north of the junction with Cornwallis Road
Union Street	From a point 74.7 metres northeast of the rear of the north- eastern footway of Cowley Road north eastwards for a distance of 1 metre
Valencia Road	that part which provides the most easterly access to Headington Road
Wytham Street	Abingdon Road - A4144 for 5 metres across the pavement."
