

**OXFORDSHIRE COUNTY COUNCIL
(VARIOUS ROADS – VALE OF WHITE HORSE DISTRICT EXCLUDING THE
PARISH OF NORTH HINKSEY) (MAP BASED) (PROHIBITION AND
RESTRICTION OF WAITING AND PERMITTED PARKING)
(VARIATION No.5) ORDER 2022**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1) and 2(1), (2) & (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Oxfordshire County Council (Various Roads – the Vale of White Horse District Excluding the Parish of North Hinksey) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.5) Order 2022 and shall come into force on the 21st day of November 2022.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
3. The substitution of any map tile herein referred to will have the effect of revoking any provision provided or designated by a previous version of that map tile and not incorporated into the latest version.

The Oxfordshire County Council (Various Roads – the Vale of White Horse District excluding the Parish of North Hinksey) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) Order 2021, as amended by the Oxfordshire County Council (Various Roads – the Vale of White Horse District excluding the Parish of North Hinksey) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.1) Order 2021, the Oxfordshire County Council (Various Roads – the Vale of White Horse District excluding the Parish of North Hinksey) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.2) Order 2021, the Oxfordshire County Council (Various Roads – the Vale of White Horse District excluding the Parish of North Hinksey) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.3) Order 2022, and the Oxfordshire County Council (Various Roads – the Vale of White Horse District excluding the Parish of North Hinksey) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.4) Order 2022, ("the 2022 Order") is amended in the manner and to the extent specified in the Schedule to this order.
