# OXFORDSHIRE COUNTY COUNCIL (OXFORD – MODIFICATION OF CONTROLLED PARKING ZONE ORDERS TO ENABLE ONLINE APPLICATIONS FOR VIRTUAL PARKING PERMITS) ORDER 2022

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35 & 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

- This Order may be cited as The Oxfordshire County Council (Oxford Modification of Controlled Parking Zone Orders to Enable Online Applications for Virtual Parking Permits) Order 2022 and shall come into force on the 23<sup>rd</sup> day of December 2022.
- 2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
  - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
  - (3) Headings are inserted for convenience and shall not affect the construction or interpretation of this Order.
- 3. The Orders listed in the Schedule to this order are amended, or further amended (as applicable) so as to insert or amend the respective definitions, articles and/or sub-paragraphs as specified in the Schedule.

(1) Any Resident who is shown by the Driver Vehicle Licensing Agency as the Registered Keeper of a vehicle of a class specified in Article 7 may apply to The Council for the issue of a Residents' Parking Permit for the leaving of that vehicle in a Residents' Permit Holders' Parking Place and any such application shall be made on a form issued by and obtainable from the Council, or via the online portal and shall include the particulars and information required by such form to be supplied."
- "15. At all times during which a vehicle is left in a Residents' Permit Holders' Parking Place during the Event Times a valid Residents' Parking Permit issued in respect of that vehicle shall, unless a Virtual Permit has been issued be displayed in the Relevant Position so that all the particulars referred to in Article 14 are readily visible from the front or nearside of the vehicle."

- "15. At all times during which a vehicle is left in a Residents' Permit Holders' Parking Place during the Event Times a valid Residents' Parking Permit issued in respect of that vehicle shall unless a Virtual Permit has been issued be displayed in the Relevant Position so that all the particulars referred to in Article 14 are readily visible from the front or nearside of the vehicle."

Each of the lengths of road specified in Part B of Schedule 5 to this Order is authorised to be used during the Prescribed Hours subject to the provisions of Part IV and Parts VI – VIII of this Order as a parking place for any Permitted Vehicle which, unless a virtual Permit has been issued displays in the Relevant Position on the vehicle a valid Residents' Permit for that vehicle for the relevant zone, a valid Temporary Permit for that vehicle for the relevant zone or a valid Visitors' Permit for the relevant zone, and each of the lengths of road specified in Zone C Part B of Schedule 5 to this Order is authorised to be used during the Prescribed Hours subject to the provisions of Part IV, Part VI and Part IX of this Order as a parking place for any Permitted Vehicle which displays in the Relevant Position on the vehicle a valid Business Permit (where applicable for that vehicle)."

### Restrictions on Parking - Permit Requirement

(1) Save as provided in Articles 12 and 13 (Exemptions), no person is to cause or permit any vehicle to wait in any Permit Parking Place specified in Zone A Part B Schedule 5 to this Order during the Prescribed Hours, except upon the direction or with the permission of a Civil Enforcement Officer, the Council or a police constable in uniform, unless either:
  - (a) a virtual Permit has been issued, or
  - (b) there is displayed in the Relevant Position on the vehicle at all times during which the vehicle is left in the Permit Parking Place during the Prescribed Hours a valid Residents' Permit in respect of that vehicle for Zone A or a valid Temporary Permit for Zone A in respect of that vehicle or a valid Visitors' Permit for Zone A provided that this requirement to display a permit does not apply to a Motor Cycle.
  - (2) Save as provided in Articles 12 and 13 (Exemptions), no person is to cause or permit any vehicle to wait in any Permit Parking Place specified in Zone B Part B Schedule 5 to this Order during the Prescribed Hours, except upon the direction or with the permission of a Civil Enforcement Officer, the Council or a police constable in uniform, unless either:
    - (a) a virtual Permit has been issued, or
    - (b) there is displayed in the Relevant Position on the vehicle at all times during which the vehicle is left in the Permit Parking Place during the Prescribed Hours a valid Residents' Permit in respect of that vehicle for Zone B or a valid Temporary Permit for Zone B in respect of that vehicle or a valid Visitors' Permit for Zone B provided that this requirement to display a permit does not apply to a Motor Cycle.
