## OXFORDSHIRE COUNTY COUNCIL (VARIOUS ROADS VALE OF WHITE HORSE DISTRICT EXCLUDING THE PARISH OF NORTH HINKSEY) (MAP BASED) (PROHIBITION AND RESTRICTION OF WAITING AND PERMITTED PARKING) (VARIATION No.7) ORDER 2022

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1) and 2(1), (2) & (3) 4(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

Amendments to "the 2021 Oder":

New definition to be added:

"Virtual Parking Permit" means a permit issued by the County Council in electronic format only, not requiring same to be displayed on a Resident Permit Holders Vehicle":

"Permit Parking Place" means any length of road specified as such in the Map Schedule to this Order which is authorised to be used as a parking place, subject to the provisions of this Order, by a Permitted Vehicle which displays in the Relevant Position a Valid Permit, or to which a Resident has been issued a Virtual Parking Permit":

3.) Amendments to article or sub-paragraphs of articles:

## Application Process (Residents)

- An application for a Residents' Permit must be made on a form issued 45. "(1) by and obtainable from the Council, or via the online portal and include the particulars and information required by such form and must be accompanied by a remittance for the Residents' Permit Charge;"
- 4.) **Application Process (Visitors)**
- An application for an allocation (25) of Visitors' Permit must be made on 51. a form issued by and obtainable from the Council, or via the online portal and include the particulars and information required by such form."
