OXFORDSHIRE COUNTY COUNCIL (OXFORD - ELECTRIC VEHICLE PARKING PLACES) (VARIATION No.5) ORDER 2023

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 32, 35, 45, 46, 49 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

- This Order may be cited as The Oxfordshire County Council (Oxford Electric Vehicle Parking Places) (Variation No.5) Order 2023 and shall come into force on the 22nd day of May 2023.
- 2. The Oxfordshire County Council (Oxford Electric Vehicle Parking Places) Order 2018, as amended by the Oxfordshire County Council (Oxford Electric Vehicle Parking Places) (Consequential Changes to Oxford – Controlled Parking Zones) Order 2018, the Oxfordshire County Council (Oxford Electric Vehicle Parking Places) (Variation No.1) Order 2018, the Oxfordshire County Council (Oxford Electric Vehicle Parking Places) (Variation No.1) Order 2020, and the Oxfordshire County Council (Oxford Electric Vehicle Parking Places) (Variation No.2) Order 2021 ("the 2018 Order") is amended in the manner and to the extent specified in the Schedule to this order.

SCHEDULE

Amendments to the articles.

1.)

The following Definition is amended:

"Prescribed Hours" means:

- in respect of the Electric Vehicle Parking Places specified in Parts A & C of Schedule 2 of this Order the period between 8am and 6:30pm Mondays to Saturdays inclusive;
- (2) in relation to the Electric Vehicle Parking Places specified in Part B of Schedule 2 of this Order the period between 8am and 6:30pm every day;

2.)

The following article is amended:

Restriction on waiting during Prescribed Hours

- 5. "Subject to item (2) below; Save as provided in Article 9 (exemptions) no person is to cause or permit any Electric Vehicle to wait in any Electric Vehicle Parking Place during the Prescribed Hours, except upon the direction or with the permission of a civil enforcement officer, the Council or a police constable in uniform:
 - (1) in respect of the parking places specified in the Schedules to this order other than those specified in (2) & (3) below,:

a) for a period longer than 3 hours; or

b) if a period of less than 3 hours has elapsed since the termination during the Prescribed Hours of the last period of parking of the Electric Vehicle in the same Electric Vehicle Parking Place

(2) In respect of the parking places specified in Schedule 2 Part C:

a) for a period longer than 5 hours; or

b) if a period of less than 3 hours has elapsed since the termination during the Prescribed Hours of the last period of parking of the Electric Vehicle in the same Electric Vehicle Parking Place.

(3) In respect of the parking places specified in Schedule 3, unless a Resident's permit is displayed on an Electric Vehicle:

a) for a period longer than 5 hours; or

b) if a period of less than 3 hours has elapsed since the termination during the Prescribed Hours of the last period of parking of the Electric Vehicle in the same Electric Vehicle Parking Place."

3.) Amendments to the Schedules.

Part A of Schedule 2 is deleted and replaced as follows:
