


**THE OXFORDSHIRE COUNTY COUNCIL  
(OXFORD - CAR CLUB PARKING PLACES)  
(VARIATION No.7) ORDER 2023**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1) & 2 (1) & (2), 4, 32, 35, 45 and 46, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 and of all other enabling powers make the following Order.

This order shall be cited as the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.7) Order 2023 and shall come into force on the 22<sup>nd</sup> day of May 2023.

  - (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
  - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.

The Oxfordshire County Council (Oxford - Car Club Parking Places) Order 2010, as amended by the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.1) Order 2012, the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.2) Order 2013, the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.3) Order 2016, the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.4) Order 2018, and the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.5) Order 2022, and the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.4) Order 2018, and the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.6) Order 2022 ("the 2010 Order") is amended in the manner and to the extent specified in the Schedule to this Order.
