

**OXFORDSHIRE COUNTY COUNCIL
(OXFORD - ELECTRIC VEHICLE PARKING PLACES)
(VARIATION No.6) ORDER 2023**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 32, 35, 45, 46, 49 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

1. This Order may be cited as The Oxfordshire County Council (Oxford Electric Vehicle Parking Places) (Variation No.6) Order 2023 and shall come into force on the 11th day of September 2023.
2. The Oxfordshire County Council (Oxford Electric Vehicle Parking Places) Order 2018, as amended by the Oxfordshire County Council (Oxford Electric Vehicle Parking Places) (Consequential Changes to Oxford – Controlled Parking Zones) Order 2018, the Oxfordshire County Council (Oxford Electric Vehicle Parking Places) (Variation No.1) Order 2018, the Oxfordshire County Council (Oxford Electric Vehicle Parking Places) (Variation No.2) Order 2020, and the Oxfordshire County Council (Oxford Electric Vehicle Parking Places) (Variation No.3) Order 2021, and the Oxfordshire County Council (Oxford Electric Vehicle Parking Places) (Variation No.5) Order 2023 is amended in the manner and to the extent specified in the Schedule to this order.

ELECTRIC TAXI PARKING PLACES

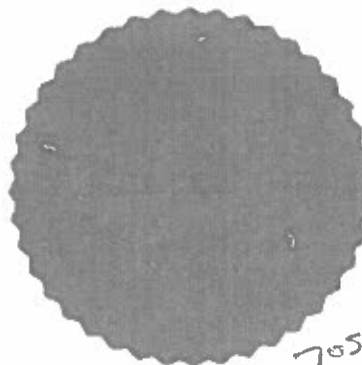
E-Taxi - One Hour Recharging, No Return within 2 hours

Keble Road	North side	from a point 37 metres east of the eastern kerb line of Banbury Road, eastwards for a distance of 11 metres.
Old Greyfriars Street	West side	a) from a point 30 metres north of the southern wall of the Westgate Shopping Centre northwards for a distance of 13 metres b) from a point 63 metres north of the southern wall of the Westgate Shopping Centre northwards for a distance of 13 metres c) from a point 92 metres north of the southern wall of the Westgate Shopping Centre northwards for a distance of 13 metres."
