

**OXFORDSHIRE COUNTY COUNCIL
(OXFORD AREA - VARIOUS STREETS)
(TRAFFIC MANAGEMENT) (VARIATION No.8) ORDER 2023**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Oxford Area - Various Streets) (Traffic Management) (Variation No.8) Order 2023 and shall come into force on the 25th day of September 2023.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.

(2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.

(3) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to a numbered Article or Schedule bearing that number in this Order.

Article amendments to the 2022 Order;

1.)

In Part 8 of the order, article 26 is deleted and replaced as follows:

Exemptions to Proceeding in One Way Streets

"Nothing in article 25 shall apply where the vehicle is:

- (1) an Exempt vehicle a);
- (2) in respect of the roads specified in Part F of Schedule 6:
 - (i) Exempt vehicles a), e) and k);
 - (ii) in pursuance of statutory duties;
 - (iii) to any vehicle waiting in any case where the person in control of the vehicle is required by law to enter the said length of road, or is obliged to do so in order to avoid an accident or is prevented from proceeding otherwise by circumstances outside his control."

In Schedule 6 the following Part F is added:

ONE WAY STREETS

"PART F

Column 1 **Road Name**

Column 2 **Direction of Travel**

1. Grove Street	From east to west
2. Mayfield Road	From Summerfield Road in a northerly and westerly direction to the junction with Banbury Road
3. Oakthorpe Road	From west to east between its junctions with Woodstock Road and Oakthorpe Place
4. South Parade	
(a) Between its junctions with Banbury Road and Stratfield Road	From east to west
(b) Between its junctions with Middle Way and Woodstock Road	From east to west

5. Summerfield Road

From west to east

6. Banbury Road Service Road

From south to north

7. Thorncliffe Road

From east to west."
