

**OXFORDSHIRE COUNTY COUNCIL
(OXFORD, MAGADALEN ROAD SOUTH AREA) (CONTROLLED
PARKING ZONE AND WAITING RESTRICTIONS) (VARIATION No.5)
ORDER 2023**

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Oxfordshire County Council (Oxford - Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) Order (Variation No.5) Order 2023 and shall come into force on the 20th day of November 2023.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment

(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa

(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment

(4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.
3. The Oxfordshire County Council (Oxford - Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) Order 2019, as amended by the Oxfordshire County Council (City of Oxford and North Hinksey) (Variation of Charges for Permits) Order 2020, the Oxfordshire County Council (Oxford - Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.1) Order 2021, the Oxfordshire County Council (Oxford - Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2021, and The Oxfordshire County Council (Oxford – Modification of Controlled Parking Zone Orders to enable online Applications for Virtual Parking Permits) Order 2022 ("the 2021 Order") is amended in the manner and to the extent specified in the Schedule to this Order.

(for Residents)

Permit Formalities

"31. A Resident's Permit or as applicable Temporary Permit will include the following particulars:
the registration number of the vehicle for which the Resident's Permit or as applicable Temporary Permit has been issued;
the period during which, subject to the provisions of Article 33 of this Order, the Resident's Permit or as applicable Temporary Permit will remain valid;
an indication that the Resident's Permit or as applicable Temporary Permit has been issued by the Council;
(1) the zonal designation RH;
(2) the zonal designation MN, or
(3) the zonal designation CM."

(for Visitors)

Permit Formalities

"38. (1) Visitor's Permits will include the following particulars:
(a) an indication that the Visitor's Permits have been issued by the Council; and
(b) the zonal designation RH
(c) the zonal designation MN, or
(d) the zonal designation CM

and may specify the period during which, subject to the provisions of Article 39, the Visitor's Permits may be used."

(for Business)

Permit Formalities

"44. A Business Permit will include the following particulars:
(1) the registration number of the vehicle for which the Business Permit has been issued;
(2) the period during which, subject always to the provisions of Article 45, the Business Permit remains valid;

- (3). an indication that the Business Permit has been issued by the Council;
- (4) the zonal designation RH
- (5) the zonal designation MN, or
- (6) the zonal designation CM."

(for Hotels)

Permit Formalities

"50.

- (1) Each Hotel Visitor's Permit will include the following particulars:
 - (i) An indication that the Hotel Visitor's Permit has been issued by the Council;
 - (ii) the zonal designation RH
 - (iii) the zonal designation MN, or
 - (iv) the zonal designation CM."

 - a) Northwest side: from a point 1.5 metres north east of the south west flank wall of No. 1a Howard Street north eastwards to the boundary between Nos. 11 and 13 Howard Street.
 - b) Northwest side: from a point 1 metre north east of the south west flank wall of No. 145 Howard Street north eastwards for a distance of 21 metres.
 - c) Northwest side: from a point 2 metres north east of the boundary between Nos. 153 & 155 Howard Street north eastwards to a point 1.5 metres south west of the boundary between Nos 165 & 167 Howard Street
 - d) Southeast side: from a point 7.5 metres south west of its junction with Cricket Road south westwards for a distance of 26 metres.
 - e) Southeast side: from a point 5 metres south west of the south west flank wall of No. 2a Howard Street south westwards for a distance of 4.5 metres.
- 5 Magdalen Road
 - a) Northwest side: from a point 17.2 metres south west of its junction with Cowley Road south westwards for a distance of 14.5 metres.
 - b) Northwest side: from a point 1 metre north east of the north east flank wall of No. 1 Magdalen Road north eastwards for a distance of 10.5 metres.
 - c) Northwest side: from the boundary between Nos. 5 and 6 Magdalen Road north eastwards to the boundary between Nos. 2 and 3 Magdalen Road.
 - d) Northwest side: from a point opposite 2 metres south west of the south west flank wall of No. 147 Magdalen Road north eastwards for a distance of 12.2 metres.
 - e) Northwest side: from the south west flank wall of No. 35 Magdalen Road north eastwards to a point 7.5 metres north east of the north east flank wall of No. 29 Magdalen Road.

- 6 Silver Road a) Southwest side: from a point 6 metres north west of its junction with Howard Street north westwards for a distance of 16 metres.

c) South west side: from a point opposite 7 metres north west of the boundary between Nos. 29 and 31 Catherine Street south eastwards to a point 1 metre north west of the south east flank wall of No. 42 Catherine Street. |

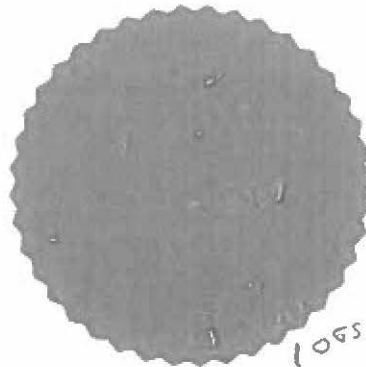
- b) South west side: from a point 1 metre south west of the north west flank wall of No. 16 Hertford Street south eastwards to the boundary between Nos. 34 and 36 Hertford Street.
- 5 Howard Street
- a) North west side: from the boundary between Nos. 31 and 33 Howard Street north eastwards to a point opposite the boundary between Nos. 48 and 50 Howard Street.
- b) North west side: from a point 1.3 metres north east of the boundary between Nos. 73 and 77 Howard Street north eastwards to a point 10.5 metres north east of the north east flank wall of No. 87 Howard Street.
- c) North west side: from a point 1.5 metres north east of the south west flank wall of No. 105 Howard Street north eastwards to the north east flank wall of No. 119 Howard Street.
- d) South east side: from a point 0.5 metres north east of the boundary between Nos. 148 and 150 Howard Street south westwards to the boundary between Nos. 136 and 138 Howard Street.
- e) South east side: from a point 1 metre south west of the boundary between Nos. 110 and 112 Howard Street south westwards to the north east flank wall of No. 96 Howard Street.
- f) South west side: from a point 2 metres south west of the boundary between Nos. 68 and 70 Howard Street south westwards to the boundary between Nos. 52 and 54 Howard Street.
- g) South west side: from a point 4.5 metres north east of the north east flank wall of No. 24 Howard Street south westwards to the boundary between Nos. 14 and 16 Howard Street.
- 6 Magdalen Road
- a) North west side: from the south west flank wall of No. 14 Magdalen Road north eastwards to the boundary between Nos. 9 and 10 Magdalen Road.
- 7 Silver Road
- a) South west side: from a point 2 metres south east of the south east flank wall of No. 2 Silver Road north westwards to the boundary between Nos. 6 and 7 Silver Road.
- b) South west side: from a point 2.5 metres north west of the boundary between Nos. 7 and 8 Silver Road north westwards to the boundary between Nos. 17 and 18 Silver Road.

There are excluded from the above lengths of road any Disabled Persons' Parking Place, any Car Club Parking Place and any Controlled Length. and any area where stands or racks or the like have been provided by the Council for cycle parking for so long as they remain in place."
