# THE OXFORDSHIRE COUNTY COUNCIL (OXFORD, MAGDALEN ROAD (NORTH) AREA) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) (VARIATION No.13) ORDER 2023

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 32, 35, 45 & 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

- This Order may be cited as the Oxfordshire County Council (Oxford Magdalen Road (North) Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.13) Order 2023 and shall come into force on the 20<sup>th</sup> day of November 2023.
  - (1) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
  - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
  - (3) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
  - (4) Any reference in this Order to a numbered Article shall unless the context otherwise requires be construed as a reference to the numbered Article bearing that number in this Order.

The Oxfordshire County Council (Oxford, Magdalen Road (North Area) (Controlled Parking Zone and Waiting Restrictions) Order 2012, as amended by the Oxfordshire County Council (Oxford, Magdalen Road (North Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No. 1) Order 2015, the Oxfordshire County Council (City of Oxford and North Hinksey) (Variation of Charges for Permits) Order 2016, the Oxfordshire County Council (Oxford, Magdalen Road (North Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.4) Order 2017, the Oxfordshire County Council (Oxford, Magdalen Road (North Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.5) Order 2019, the Oxfordshire County Council (Oxford, Magdalen Road (North Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.6) Order 2019, the Oxfordshire County Council (City of Oxford and North Hinksey) (Variation of Charges for Permits) Order 2020, the Oxfordshire County Council (City of Oxford) (Modification of Renewal Mechanism for Residents Permits and Visitors Permits) Order 2021, the Oxfordshire County Council (Oxford Magdalen Road (North) Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.9) Order 2022, the Oxfordshire County Council (Oxford Magdalen Road (North) Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.10) Order

2022, The Oxfordshire County Council (Oxford – Modification of Controlled Parking Zone Orders to enable online Applications for Virtual Parking Permits) Order 2022, and the Oxfordshire County Council (Oxford Magdalen Road (North) Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.12) Order 2023 ("the 2007 Order") is amended in the manner and to the extent specified in the Schedule to this Order.

### **SCHEDULE**

#### Amendments to "the 2012 Order"

The below articles are amended as highlighted:

(for Residents)

#### **Permit Formalities**

- "33. A Residents' Permit or as applicable Temporary Permit will include the following particulars:
- the registration number of the vehicle for which the Residents' Permit or as applicable Temporary Permit has been issued;
- (2) the period during which, subject to the provisions of Article 35 of this Order, the Residents' Permit or as applicable Temporary Permit will remain valid;
- (3) an indication that the Residents' Permit or as applicable Temporary Permit has been issued by the Council; and
- (4) 4) the zonal designation 'MN', or
- (5) the zonal designation 'RH'."

(for Visitors)

#### **Permit Formalities**

- "40.(1) Visitors' Permits will include the following particulars:
  - (a) an indication that the Visitors' Permits have been issued by the Council; and
  - (b) the zonal designation 'MN', or
  - (c) the zonal designation 'RH'

and may specify the period during which, subject to the provisions of Article 41, the Visitors' Permits may be used."

# (for Businesses)

## **Permit Formalities**

- "46. A Business Permit will include the following particulars:
- (1) the registration number of the vehicle for which the Business Permit has been issued;
- (2) the period during which, subject always to the provisions of Article 47, the Business Permit remains valid;
- (2) an indication that the Business Permit has been issued by the Council;
- (3) the zonal designation 'MN', or
- (4) the zonal designation 'RH'."

(for Hotels)

## **Permit Formalities**

- "52. (1) Each Hotel Visitors' Permit will include the following particulars:
  - (i) An indication that the Hotel Visitors' Permit has been issued by the Council;
  - (ii) The zonal designation 'MN', or
  - (iii) the zonal designation 'RH'."
