

**OXFORDSHIRE COUNTY COUNCIL  
(VARIOUS ROADS – CHERWELL DISTRICT) (MAP BASED) (PROHIBITION AND  
RESTRICTION OF WAITING AND PERMITTED PARKING) (VARIATION No.9)  
ORDER 2023**

The Oxfordshire County Council in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984, and The Traffic Management Act 2004, Part 6 (as amended) make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Various Roads - Cherwell District) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.9) Order 2023.  
  
  - (1) In respect of restricted or prohibited parking mapped and specified in schedule 2 to this order the measures shall come into force on the 18<sup>th</sup> day of December 2023; and
  - (2) in respect of schedules 3 to 6 specified in this order regarding permit parking and conditions, shall come into force on the 15<sup>th</sup> day of January 2024.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
