OXFORDSHIRE COUNTY COUNCIL (VARIOUS ROADS - SOUTH OXFORDSHIRE) (MAP BASED) (PROHIBITION AND RESTRICTION OF WAITING AND PERMITTED PARKING) (VARIATION No.14) ORDER 2024

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1) and 2(1), (2) & (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

- This Order may be cited as the Oxfordshire County Council (Various Roads South Oxfordshire) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.14) Order 2024 and shall come into force on the 29th day of January 2024.
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 3. The substitution of any map tile herein referred to will have the effect of revoking any provision provided or designated by a previous version of that map tile and not incorporated into the latest version.

 In article 2 `Definitions` the following entry is replaced:

"the Council" means Oxfordshire County Council as Traffic Authority and where appropriate South Oxfordshire District Council or Thame Town Council acting on behalf of the Traffic Authority as agent;"

In article 2 'Definitions' the following new entries are placed:

"Street Trader" means a business granted permission for selling, exposing or offering articles for sale in the street, by South Oxfordshire District Council.

"Street Trader Permit" means a permit issued by the Council to a Street Trader under the provisions of Part IX of this Order:

- "Street Trader Parking Place Identifier" means the code which identifies each Street Trading Parking Place as specified:
- (a) in the Traffic Sign placed in the vicinity of that Street Trading Parking Place;
- (b) in the Street Trading Permit for use in relation to that Street Trading Parking Place; and
- (c) in the Map Tile Label related to that Street Trading Parking Place in the Map Schedule to this Order:

"Street Trader Parking Place" means any length of highway specified as such in the Map Schedule to this Order, which is authorised to be used as a parking place for a

vehicle, subject to the provisions of this Order, with each Street Trader Parking Place having a Street Trading Place Identifier;"

2.)

New articles are added after article 23 as follows:

"General

24A. The provisions of Part V of this Order apply to Parking Places.

24B. Traders Permits

Where the Council or its agent, in the exercise of its discretion agrees to authorise the use of any Parking Place by a contractor undertaking any demolition, excavation or building or maintenance operations or repair works at premises in any roads stated in Schedule 2 to this Order, the charge for such authorisation will be £7.50 daily."

3.)

New articles are added after article 61 as follows:

"Street Trader Permit

Application

- 61A. A Street Trader may apply to the Council for the issue of a Street Trader
 Permit for the leaving, subject to provisions of this Order, during the
 Prescribed Hours in a Street Trader Parking Place of a Permitted Vehicle that:
 - (1) The Street Trader has valid Street Trading Consent by South Oxfordshire District Council to operate at the locations specified in schedule 3 and can provide evidence as part of the application.
 - (2) The relevant fee specified in schedule 4 has been provided.

Permit Terms

- 61B. (1) A Street Traders Permit may be valid for a period of 12 months.
 - (2) The Council will fix a day when a Street Traders Permit will cease to be valid.
 - (3) No more than one Street Traders Permit which is valid at the same time will be issued for each Street Traders Parking Place.
 - (4) The charge for each Street Traders Permit will be specified in column 3 of Schedule 4 for each period of validity stated in column 4 of that

Schedule and the charge is payable on or before the issue of the permit.

Application Process

- 61C. (1) An application for a Street Traders Permit must be made on a form issued by and obtainable from the Council and include the particulars and information required by such form and must be accompanied by a remittance for the charge specified in Article 56(4).
 - (2) The Council may require an applicant for a Street Traders Permit to produce such evidence in respect of its application as the Council may reasonably require to verify any particulars or information given to the Council including Street Trading Consent by South Oxfordshire District Council.
 - (3) The Council will not issue a Street Traders Permit for a Street Traders Parking Place if a Street Traders Permit which remains valid has been issued for that Street Traders Parking Place.

Replacement Permit

- 61D. (1) A Car Club Permit will become invalid if it is mutilated or accidentally defaced or the figures or particulars on it have become illegible or the colour of the Car Club Permit has become altered by fading or otherwise, and the Car Club Operator will either surrender it to the Council or apply to the Council for the issue of a replacement Car Club Permit by completing the application form obtainable from the Council.
 - (2) A Car Club Permit will become invalid if it is lost or destroyed and the Car Club Operator may apply to the Council for the issue of a replacement Car Club Permit and the Council, upon being satisfied as to such loss or destruction, will issue a replacement Car Club Permit so marked.
 - (3) The provisions of this Part of this Order will apply to a replacement Car Club Permit, or an application for it, as if it were an original Car Club Permit or as the case may be an application for it."
