# OXFORDSHIRE COUNTY COUNCIL (OXFORD, MAGADALEN ROAD SOUTH AREA) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) (VARIATION No.6) ORDER 2024

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

- This Order may be cited as the Oxfordshire County Council (Oxfordshire County Council (Oxford - Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) Order (Variation No.6) Order 2024 and shall come into force on the 29<sup>th</sup> day of January 2024.
- 2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
  - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
  - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.
- 3. The Oxfordshire County Council (Oxford Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) Order 2019, as amended by the Oxfordshire County Council (City of Oxford and North Hinksey) (Variation of Charges for Permits) Order 2020, the Oxfordshire County Council (Oxford Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.1) Order 2021, the Oxfordshire County Council (Oxford Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2022, and the Oxfordshire County Council (Oxford Modification of Controlled Parking Zone Orders to enable online Applications for Virtual Parking Permits) Order 2022, the Oxfordshire County Council (Oxford Magdalen Road South Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.5) Order 2023 ("the 2021 Order") is amended in the manner and to the extent specified in the Schedule to this Order.
