OXFORDSHIRE COUNTY COUNCIL (WEST OXFORD AND OSNEY MEAD) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) (CONSOLIDATION) (VARIATION No.16) ORDER 2024

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 32, 35, 45, 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

- This Order may be cited as The Oxfordshire County Council (West Oxford and Osney Mead) (Controlled Parking Zone and Waiting Restrictions) Consolidation (Variation No.16) Order 2024 and shall come into force on the 12th day of February 2024.
- (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
 - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
 - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.

Amendment to "the 2009 Order"

PART D of Schedule 4 replaced as follows:

"PART D

1 TIMED PARKING PLACES - TWO HOUR PARKING PLACES 8.00 AM - 6.30 PM MONDAY TO FRIDAY PERMIT HOLDERS ARE EXEMPT FROM TIME LIMIT

- 1. Ferry Hinksey Road
- (a) West side in layby; from a point 27 metres south of the northern boundary of the Oatlands Road Recreation Ground, southwards for a distance of 15.5 metres
- (b) West side in layby; from a point 46.5 metres south of the northern boundary of the Oatlands Road Recreation Ground, southwards for a distance of 49.5 metres

- (c) West side in layby; from a point 100 metres south of the northern boundary of the Oatlands Road Recreation Ground, southwards for a distance of 50 metres
- (d) West side in layby; from a point 7 metres south of a point opposite the southern highway boundary of Osney Mead (at its junction with Ferry Hinksey Road), southwards for a distance of 20 metres
- Osney Mead (northern part)
- (a) North side; from a point 78 metres west of the western boundary of footpath 320/110, westwards for a distance of 18.5 metres.
- (b) South side;
 - (i) from a point 30 metres east of the eastern highway boundary of Ferry Hinksey Road, eastwards for a distance of 62 metres.
 - (ii) from a point 20 metres east of the eastern highway boundary of Osney Mead (western part), eastwards for a distance of 36 metres.
 - (iii) from a point 21 metres west of the eastern end of Osney Mead (northern part), westwards for a distance of 40 metres.
- 3. Osney Mead (eastern part)
- (c) Northwest side; from a point 71 metres northeast of the south-western end of Osney Mead (eastern part), north-eastwards for a distance of 30 metres.

There are excluded from the above lengths of road any Disabled Persons Parking Places and any Controlled Length"
