# OXFORDSHIRE COUNTY COUNCIL (SOUTH OXFORD EXTENSION) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) VARIATION No.2) ORDER 2024

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

- 1. This Order may be cited as the Oxfordshire County Council (South Oxford Extension) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2024 and shall come into force on the 29<sup>th</sup> day of April 2024.
- 2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
  - (3) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to a numbered Article or Schedule bearing that number in this Order.
- 3. The Oxfordshire County Council (South Oxford Extension) (Controlled Parking Zone and Waiting Restrictions) Order 2022, as amended by the Oxfordshire County Council (Oxford Modification of Controlled Parking Zone Orders to Enable Online Applications for Virtual Parking Permits) Order 2022 ("the 2021 Order") is amended in the manner and to the extent specified in the Schedule to this Order.

"Hotel Visitor's Permit" means a permit issued by the Council to a hotel or guesthouse under the provisions of Part VIII of this Order to park a Permitted Vehicle, subject to the provisions of this Order, in the Parking Places specified in Schedules 4 & 5;"

'Prescribed Hours' means:

- (1) in respect of parking places specified in Schedule 4,
- A. Permit Parking Places 8.00am to 8.00pm Monday to Saturday
- B. Two Hour Parking Places 8.00am to 8.00pm Monday To Saturday No Return Within 2 Hours;
- (2) in respect of parking places specified in Schedule 5,
- A. Permit Parking Places 8.00am to 8.00pm Monday to Sunday
- B. One Hour Parking Places 8.00am to 8.00pm Monday to Sunday No Return Within 1 Hour (permit holders exempt from time limit)."

3.)
Articles 14 and 15 are deleted and replaced as follows:

### PART IV PARKING PLACES

### "Designation of Parking Places

- Each of the lengths of road specified in Schedules 4 and 5 to this Order, excluding;
  - (1) any Restricted Road
  - (2) any parts which may reasonably be used by a vehicle to get to or from any road;
  - (3) any Access Way; and
  - (4) any Controlled Length

is authorised to be used, subject to the provisions of Part III and IV of this Order, as a parking place for vehicles.

### **Time Restriction on Waiting during Prescribed Hours**

- 15. Save as provided in Articles 10 and 11 (Exemptions) or unless there is compliance with Article 18 (Permit Parking) no person is to cause or permit any vehicle other than a Motor Cycle to wait in any Parking Place during the Prescribed Hours, except upon the direction or with the permission of a Civil Enforcement Officer, the Council or a police constable in uniform:
  - (1) (a) in the roads specified in Schedule 4 (during the relevant period of Prescribed Hours) for a period longer than 2 hours; or
  - (b) if a period of less than 2 hours has elapsed since the termination during the Prescribed Hours of the last period of parking of the vehicle in the same Parking Place.
  - (2) (a) in the roads specified in Schedule 5 (during the relevant period of Prescribed Hours) for a period longer than 1 hour; or
  - (b) if a period of less than 1 hour has elapsed since the termination during the Prescribed Hours of the last period of parking of the vehicle in the same Parking Place."
