OXFORDSHIRE COUNTY COUNCIL (OXFORD AREA - VARIOUS STREETS) (TRAFFIC MANAGEMENT) (VARIATION No.11) ORDER 2024

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

- This Order may be cited as the Oxfordshire County Council (Oxford Area -Various Streets) (Traffic Management) (Variation No.11) Order 2024 and shall come into force on the 20th day of May 2024.

- (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
- (3) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to a numbered Article or Schedule bearing that number in this Order.

Articles 13D & E are deleted and replaced as follows:

"ANPR ENFORCEMENT

- 13D Save as provided in article 13E of this order, no person shall cause any motor vehicle proceeding in a road specified in column 1 of Part 1 of Schedule 1 to this order to proceed beyond the point specified in column 2.
- 13E Nothing in article 13D of this order shall apply to the lengths of road specified in column 2 of Part I of Schedule 1 if being used for any of the following purposes:
- a) vehicle in the service of or employed by the fire, police or ambulance services when on an emergency call;
- b) police vehicle on patrol;
- c) vehicle of a Universal Service Provider which has the meaning given in Section 4
 of the Postal Services Act 2000, and is employed for the purpose of loading,
 unloading, delivering or collecting postal packets at premises or posting boxes;
- d) vehicle in the service of a local authority being used for waste collections or street cleansing operations;
- e) a Taxi or Private Hire Vehicle."
