OXFORDSHIRE COUNTY COUNCIL (OXFORD, COWLEY CENTRAL EAST AREA) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) (VARIATION No.6) ORDER 2024

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

- 1. This Order may be cited as the Oxfordshire County Council (Oxford, Cowley Central East Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.6) Order 2024 and shall come into force on the 19th day of August 2024.
- (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
 - (3) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to a numbered Article or Schedule bearing that number in this Order.
- 3. The Oxfordshire County Council (Oxford, Cowley Central East Area) (Controlled Parking Zone and Waiting Restrictions) Order 2021, as amended by the Oxfordshire County Council (Oxford, Cowley Central East Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.1) Order 2022, the Oxfordshire County Council (Oxford, Cowley Central East Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2022, the Oxfordshire County Council (Oxford, Cowley Central East Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.3) Order 2022, the Oxfordshire County Council (Oxford Modification of Controlled Parking Zone Orders to Enable Online Applications for Virtual Parking Permits) Order 2022, and the Oxfordshire County Council (Oxford, Cowley Central East Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.5) Order 2024 ("the 2021 Order") is amended in the manner and to the extent specified in the Schedule to this Order.
