The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) and (2), 4(1) and (2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

### PART 1

### **GENERAL**

 This Order may be cited as the Oxfordshire County Council (City of Oxford and Cherwell District) (Bus Lanes) Order 2025 and shall come into force on the 21<sup>st</sup> day of January 2025.

### **Definitions**:

2. In this Order, except where the context otherwise requires the following expressions have the following meanings;

"Blood Bike(s)" means a motor cycle (or other class of motor vehicle) marked with yellow and red reflective livery and with a logo displaying the word "BLOOD" and associated words/badges and being used by a charity for the collection and delivery of blood related products and organs;

"Blood Bike Charity" means a charity in support of the NHS and other medical organisations and operated by SERV OBN Blood Bikes, Sunny Bank, High Street, Ramsden, Chipping Norton, Oxon, OX7 3AU;

"bus" means:

- (a) a motor vehicle constructed or adapted to carry more than eight passengers (exclusive of the driver); or
- (b) a local bus not so constructed or adapted.

"bus lane" means any of the lengths of road specified in Schedule 1 to this order;

"bus lanes hours" means the whole twenty-four hours of every day of the week;

"Civil Enforcement Officer – CEO" means a person authorised under section 76 of the Traffic Management Act 2004 to undertake enforcement of parking contraventions (as defined in that act);

"Clearway Hours" means the periods of no stopping or waiting:

(i) In respect of the lengths of road specified in Schedule 2 to this order: between 7.30 and 9.30am and between 4.00 and 6.30pm on Monday to Saturday inclusive;

 (ii) In respect of the lengths of road specified in Schedule 4 to this order: for 24 hours of very day;

"cycle" means a cycle which has two or more wheels not being a motor vehicle;

"disabled persons badge", "parking disc" and "relevant position" having the meanings ascribed to them in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"disabled persons' vehicle" means a vehicle lawfully displaying in the relevant position a disabled persons' badge;

"E-Scooter" means a motor vehicle which -

(a) is fitted with an electric motor with a maximum continuous power rating not exceeding 500 watts;

(b) is not fitted with pedals that are capable of propelling the vehicle;

(c) has two wheels, one front and one rear, aligned along the direction of travel;

(d) is designed to carry no more than one person;

(e) has a maximum weight, excluding the driver, not exceeding 55 kilograms;

(f) has a maximum design speed not exceeding 15.5 miles per hour;

(g) has a means of directional control through the use of handlebars which are mechanically linked to the steered wheel;

(h) has a means of controlling the speed through hand controls; and

(i) has a power control that defaults to the 'off' position."

"local bus" means a public service vehicle (as defined in Section 1 of the Public Passenger Vehicle Act 1981) for the provision of a local service not being an excursion or tour;

"local service" has the meaning given in Section 2 of the Transport Act 1985 being a service using one or more public service vehicles (as defined in Section 1 of the Public Passenger Vehicle Act 1981) for the carriage of passengers by road at separate fares other than:

(a) a service in relation to which (except in an emergency) every passenger using the service is set down at a place 15 miles or more, measured in a straight line, from the place they were taken up and/or some point on route between those places is 15 miles or more, measured in a straight line, from either of those places; or

(b) a service excluded as set out in section 2(4) of the Transport Act 1985.

"Penalty charge" and "reduced penalty charge" means a charge set by the council under regulation 4 of The Bus Lane Contraventions (Penalty Charge, Adjudication and Enforcement) (England) Regulations 2005 ("the 2005 regulations").

"Penalty charge notice" or "PCN" means a notice issued by a Civil Enforcement Officer pursuant to regulations made by Part 6 of the Traffic Management Act 2004;

"postal packet" means a letter, parcel, packet or other article transmitted by post;

"private hire vehicle" means a vehicle as described in Section 80 of Local Government (Miscellaneous Provisions Act 1976) and licensed under Section 48 of that Act;

"public service vehicle" has the meaning given in Section 1 of the Public Passenger Vehicle Act 1981; "restricted hours" means the whole twenty-four hours of every day;

"restricted road" means any length of road specified in the Schedules to this Order;

"taxi" means a vehicle licensed under section 37 of the Town Police Clauses Act 1847;

"traffic sign" means any object, device, line or mark for conveying to traffic warnings, information, requirements, restrictions or prohibition of any description as provided in Section 64 of the Act;

"universal service provider" has the meaning given in Section 4 of the Postal Services Act 2000.

- 3. (1) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment
  - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa
  - (3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment
  - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.

## PART II

## **BUS LANES**

4. Subject to articles 7 (Barton Fields) and 8 (A40 Northern Bypass), save as provided in Articles 5 and 6 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to enter, proceed or be in any of the lengths of road described in Schedule 1 to this Order during the bus lane hours.

5. Nothing in Article 4 of this Order shall apply to any:

- (1) bus (including but not by way of limitation a bus being used in the provision of a local service waiting at any bus stop in order to set down or pick up passengers);
- (2) cycle;
- (3) ambulance;
- (4) vehicle of the fire service in an emergency;
- (5) police vehicle;
- (6) taxi (including but not by way of limitation in order to set down or pick up passengers);
- (7) private hire vehicle (including but not by way of limitation in order to set down or pick up passengers);
- (8) vehicle that has entered the length of road described in Schedule 1 (Botley Road) for the sole purpose of gaining access to Seacourt Park & Ride Car Park;
- (9) Blood Bike
- (10) E-Scooter.
- 6. Nothing in Article 4 of this Order shall apply so as to prevent a vehicle using any of the lengths of road described in Schedule 1 to this Order for so long as it may be necessary to enable it to be so used, for any of the following purposes or eventualities.
  - (1) when the person in control of the vehicle is required by law to enter proceed or stop in the relevant length of road or is obliged to do so in order to avoid an accident or is prevented from avoiding in the relevant length of road by circumstances outside his control;
  - (2) when the vehicle is waiting while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait otherwise than in the relevant length of road while such gate or other barrier is being opened or closed;
  - (3) the vehicle is in the service of a local authority or water undertaking in pursuance of statutory powers or duties;

- (4) the vehicle is in the service of a universal service provider and is waiting while postal packets are being loaded, unloaded, delivered or collected from premises or posting boxes in or adjacent to the relevant length of road ;
- (5) to enable a vehicle to cross the relevant length of road to get to or from any road or layby adjacent to the relevant length of road or any vehicular access to premises adjacent to the relevant length of road ;
- (6) to enable a person to board or alight from a vehicle outside the clearway hours only.
- 7. In respect only of Barton Fields in Schedule 1 nothing in Article 4 of this Order shall apply to any:

(1) bus (including but not by way of limitation a bus being used in the provision of a local service waiting at any bus stop in order to set down or pick up passengers);

(2) cycle;

- (3) ambulance or vehicle of the fire service in an emergency;
- (4) police vehicle on patrol;
- (5) vehicle for so long as it may be necessary to enable it to be used for any of the following purposes:
- (6) when the person in control of the vehicle is required by law to enter proceed or stop in the relevant length of road or is obliged to do so in order to avoid an accident or is prevented from avoiding in the relevant length of road by circumstances outside his control;
- (7) for works associated with the highway, utilities or communications;
- (8) the vehicle is in the service of a local authority or water undertaking in pursuance of statutory powers or duties.
- 8. In respect only of A40 Northern Bypass Road in Schedule 1 nothing in Article 4 of this Order shall apply to any:
  - (1) bus (including but not by way of limitation a bus being used in the provision of a local service waiting at any bus stop in order to set down or pick up passengers);
  - (2) cycle;
  - (3) ambulance;

- (4) vehicle of the fire service in an emergency;
- (5) police vehicle;
- (6) Blood Bike.
- 9. In respect only of Barton Fields Link road specified in Schedule 1, no exemption shall apply to a taxi or private hire vehicle.

# PART III

#### **PROHIBITION OF WAITING**

- 10. Save as provided in Articles 11, 12 & 13 (as appropriate) of this Order no person shall, except upon the direction or with the permission of a CEO or a police constable in uniform, cause or permit any vehicle to wait at any time in any restricted road.
- 11. Nothing in Article 10 of this Order shall apply to any:
  - (1) ambulance;
  - (2) vehicle of the fire service in an emergency;
  - (3) police vehicle;
  - (4) Bus being used in the provision of a Local Service waiting at any bus stop in order to set down or pick up passengers;
  - (5) Taxi or Private Hire vehicle in order to set down or pick up passengers only.
  - 12. Nothing in Article 10 of this Order shall apply so as to prevent a vehicle waiting in any of the restricted roads for any of the following purposes or eventualities, for so long only as may be necessary to enable it to be so used;
    - when the person in control of the vehicle is required by law to stop or is obliged to do so in order to avoid an accident or is prevented from proceeding by circumstances outside his control;
    - (2) where the vehicle is waiting while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait otherwise than in the road while such gate or other barrier is being opened or closed;

- (3) the vehicle is in the service of a local authority or water undertaking in pursuance of statutory powers or duties;
- (4) the vehicle is in the service of a universal service provider and is waiting while postal packets are being loaded, unloaded, delivered to or collected from premises or posting boxes, in or adjacent to the road.
- 13. Nothing in Article 10 of this order shall apply to a vehicle waiting outside the clearway hours in any restricted road (save that the following exemptions shall only operate in respect of any part of a restricted road which is a bus lane upon the direction or with the permission of a police constable in uniform or the Council)
  - for so long as it may be necessary to enable the vehicle to be used in connection with any of the following, if it cannot conveniently be so used without waiting in the road;
    - (a) undertaking any building operation, demolition or excavation;
    - (b) removing any obstruction to traffic;

(c) undertaking works in relation to any sewer or water main or in relation to the supply of gas, water, electricity or communication services;

(d) undertaking works in relation to the road, a traffic sign, street lighting or other highway equipment;

(e) in connection with any funeral.

- (2) for the purpose of loading or unloading a vehicle at premises situated on or adjacent to the road;
- (3) for as long at may be necessary to enable a person to board or alight from the vehicle;
- (4) if it is a disabled person's vehicle which lawfully displays in the relevant position a disabled person's badge waiting for a period not exceeding three hours (not being a period separated by an interval of less than hour from a previous period of waiting by the same vehicle in the same length of road on the same day) provided that there is displayed in the relevant position on the vehicle a parking disc marked to show the quarter hour period during which the period of waiting began,

provided in each case that the person in control of the vehicle shall move it on the instruction of a police constable in uniform where this shall be necessary for the purposes of preventing obstruction.

#### PART IV

#### **CLEARWAYS**

- 14 Save as provided in Articles 15, 16 or 17 of this Order no person shall, except upon the direction or with the permission of a CEO or a police constable in uniform, cause or permit any vehicle to stop or to wait during Clearway Hours in any of the lengths of Clearway specified in Schedules 2 and 3 to this order.
- 15. Nothing in Article 14 of this Order shall apply to any:
  - (1) Police, fire or ambulance vehicle in an emergency
  - (2) Bus being used in the provision of a Local Service waiting at any bus stop in order to set down or pick up passengers.
- 16. Nothing in Article 14 of this Order shall apply so as to prevent a vehicle waiting in any Clearway for any of the following purposes or eventualities, for so long only as may be necessary to enable it to be so used;
  - when the person in control of the vehicle is required by law to stop or is obliged to do so in order to avoid an accident or is prevented from proceeding by circumstances outside his control;
  - (2) where the vehicle is waiting while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it is emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait otherwise than in the road while such gate or other barrier is being opened or closed;
  - (3) the vehicle is in the service of a local authority or water undertaking in pursuance of statutory powers or duties;
  - (4) the vehicle is in the service of a universal service provider and is waiting while postal packets are being loaded, unloaded, delivered to or collected from premises or posting boxes, in or adjacent to the road.

- 17. Nothing in Article 14 of this order shall apply to a vehicle waiting for so long as it may be necessary to enable the vehicle to be used in connection with any of the following, if it cannot conveniently be so used without waiting in the road;
  - (a) undertaking any building operation, demolition or excavation;
  - (b) removing any obstruction to traffic;
  - (c) undertaking works in relation to any sewer or water main or in relation to the supply of gas, water, electricity or communication services;
  - (d) undertaking works in relation to the road, a traffic sign, street lighting or other highway equipment.

## PART V CONTRAVENTIONS OF THE ORDER

18. (1) if a vehicle is left at any time in contravention of a waiting provision, or driven in contravention of any provision within this Order a penalty charge will be payable.

(2) in the case of a vehicle in respect of which a penalty charge is payable a penalty charge notice may be issued by a civil enforcement officer.
