OXFORDSHIRE COUNTY COUNCIL (NORTH SUMMERTOWN) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) (VARIATION No.36) ORDER 2025

Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35, 45 & 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, make the following Order.

- 1. This Order may be cited as the Oxfordshire County Council (North Summertown) (Controlled Parking Zone and Waiting Restrictions) (Variation No.36) Order 2025 and shall come into force on the 27th day of January 2025.

 - (2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
