

**OXFORDSHIRE COUNTY COUNCIL
(VARIOUS ROADS – CHERWELL DISTRICT) (MAP BASED) (PROHIBITION AND
RESTRICTION OF WAITING AND PERMITTED PARKING) (VARIATION No.16)
ORDER 2025**

The Oxfordshire County Council in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2), 32(1), 35(1), 37, 45, 46, 49(4) and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Various Roads - Cherwell District) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.16) Order 2025 and shall come into force on the 17th day of March 2025.
