

**OXFORDSHIRE COUNTY COUNCIL
(VARIOUS ROADS - SOUTH OXFORDSHIRE) (MAP BASED) (PROHIBITION
AND RESTRICTION OF WAITING AND PERMITTED PARKING)
(VARIATION No.24) ORDER 2025**

The Oxfordshire County Council (“the Council”) in exercise of its powers under Sections 1(1) and 2(1), (2) & (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Oxfordshire County Council (Various Roads – South Oxfordshire) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) (Variation No.24) Order 2025 and shall come into force on the 17th day of March 2025.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
