OXFORDSHIRE COUNTY COUNCIL (OXFORD, COWLEY CENTRAL (WEST) AREA) (CONTROLLED PARKING ZONE AND WAITING RESTRICTIONS) (VARIATION No.6) ORDER 2025

The Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) & (2), 32, 35, 45 & 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

- This Order may be cited as the Oxfordshire County Council (Oxford, Cowley Central West Area) (Controlled Parking Zone And Waiting Restrictions) (Variation No.6) Order 2025 and shall come into force on the 26th day of May 2025.
- (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.
 - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
 - (3) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the numbered Article or Schedule bearing that number in this Order.

The Oxfordshire County Council (Oxford, Cowley Central West Area) (Controlled Parking Zone and Waiting Restrictions) Order 2021, as amended by the Oxfordshire County Council (Oxford, Cowley Central West Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.1) Order 2022, the Oxfordshire County Council (Oxford, Cowley Central West Area) (Controlled Parking Zone and Waiting Restrictions) (Variation No.2) Order 2022, the Oxfordshire County Council (Oxford Modification of Controlled Parking Zone Orders to enable online Applications for Virtual Parking Permits) Order 2022, the Oxfordshire County Council (Oxford, Cowley Central West Area) (Controlled Parking Zone And Waiting Restrictions) (Variation No.4) Order 2024, and the Oxfordshire County Council (Oxford, Cowley Central West Area) (Controlled Parking Zone And Waiting Restrictions) (Variation No.5) Order 2024 ("the 2021 Order") is amended in the manner and to the extent specified in the Schedule to this Order.
