

**OXFORDSHIRE COUNTY COUNCIL
(OXFORD - CAR CLUB PARKING PLACES) (VARIATION No.8) ORDER 2025**

Oxfordshire County Council ("the Council") in exercise of its powers under Sections 1(1) & 2 (1) & (2), 4, 32, 35, 45 and 46, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984") and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 and of all other enabling powers make the following Order.

1. This order shall be cited as the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.8) Order 2025 and shall come into force on the 28th day of July 2025.
2. (1) Any reference in this Order to any enactment (meaning any act and any subordinate legislation as defined in the Interpretation Act 1978) shall be construed as a reference to that enactment as amended or replaced by any subsequent enactment.

(2) Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa

(3) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other enactment.
3. The Oxfordshire County Council (Oxford - Car Club Parking Places) Order 2010, as amended by the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.1) Order 2012, the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.2) Order 2013, and the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.3) Order 2016, the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.4) Order 2018, the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.5) Order, the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.6) Order 2022, and the Oxfordshire County Council (Oxford - Car Club Parking Places) (Variation No.7) Order 2023 ("the 2010 Order") is amended in the manner and to the extent specified in the Schedule to this Order.
