# (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2011 (VARIATION NO.21) ORDER 2021

The Pembrokeshire County Council ('the Council') in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46,49, 53, 101, 102, 124 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended, the provisions of the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers of the Act, and after consulting the Chief Officer of Police in accordance with Part IV of Schedule 9 to the 1984 Act hereby make the following Order:-

- This Order shall come into operation on the 12th day of July 2021 and may be cited as the Pembrokeshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2011 (Variation No. 21) Order 2021.
- 2. The Pembrokeshire County Council (Prohibition and Restriction of Waiting, Loading and Parking Places) Consolidation Order 2011 ("the Consolidation Order") including the schedules contained therein and subsequent variations are hereby varied or amended as follows:-

# 1) Amendment of Schedule 2

(a) In Schedule 2.1, insert:-

## **Freshwater West**

### **B4319**

West side – i) From a point 148 metres south of the bridge southwards for 15 metres ii) from a point 280 metres south of the bridge southwards for 15 metres

### **Haverfordwest**

## Hole in the Wall

Both sides - From its junction with Bridge Street, north east to the end of public highway

## Neyland

## **Harbour Close**

Both sides – from its junction with Riverside Avenue west for 10 metres.

#### **Riverside Avenue**

West side – from a point 12 metres north of the centreline of Harbour Close, south for a distance of 42 metres.

# 2. Amendment to Schedule 4

Schedule 4.8, insert:-

### U6338 Beach Road

South side – from a point 345 metres west of the access road leading towards Manorbier Mill westwards for 22 metres to provide 6 disabled bays

## 3) Revocations

Those lengths of road contained in "the Consolidation Order" including the schedules therein and subsequent variations are hereby revoked where specifically mentioned or where the amendment as contained in this Order provides a new definition of the restriction to apply to that section of highway.
