

PEMBROKESHIRE COUNTY COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING
PLACES) (CONSOLIDATION) ORDER 2011 (VARIATION NO.7) ORDER 2014

The Pembrokeshire County Council ('the Council') in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49, 53, 101, 102, 124 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act') as amended, the provisions of the Traffic Management Act 2004 ('the 2004 Act') and of all other enabling powers of the Act and after consulting the Chief Officer of Police in accordance with Part IV of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. This Order shall come into operation on the 7th day of April 2014 and may be cited as the Pembrokeshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2011 (Variation No. 7) Order 2014.
2. The Pembrokeshire County Council (Prohibition and Restriction of Waiting, Loading and Parking Places) Consolidation Order 2011 ('the Consolidation Order') including the schedules contained therein and subsequent variations are hereby varied or amended as follows:-

3) Amendment of Schedule 2

(a) In Schedule 2.1, insert:-

Milford Haven

Albion Street

East side – from the boundary of Nos 35/37 south for 8 metres.

West side – from the junction with Imogen Place north for 5 metres.

Imogen Place

North side – from the junction with Albion Street west for 5 metres

Neyland

Brunel Avenue

Both sides – from the junction with Riverside Avenue, east for 15 metres.

Pembroke

East Back

West side – at the eastern junction with Main Street, north to the entry to the Wesley car park, a length of about 18 metres.

West and south side – from the access to Wesley car park, north then west to a point on the line of the Wesley Hall forecourt wall, a length of about 28 metres.

East side – at the eastern junction with Main Street, north to the line of the frontage of Nos 90-94 a length of about 19 metres.

Main Street

North side – f) from the east junction with East Back east to the limited waiting spaces at the access to St Michaels car park, including both sides of the access to St Michaels Church.

g) from the limited waiting spaces at the access to St Michaels car park, east to a point 1 metre west of the extended boundary of Nos 104/106, a length of about 17 metres.

h) from a point 1 metre west of the extended boundary of Nos 110/112 east to a point 3 metres east of the west gable of No.120, a length of about 37 metres.

South side – e) the 4 metre length across the footway buildout adjacent to No.105.

f) the 12 metre length across the footway buildout adjacent to No.115

g) the 9 metre length across the footway buildout adjacent to No.127

Lower Row / Wiston Street

North side – from the boundary of Castle View / Margareta westwards to and including the turning area.

South side – from a point 15 metres west of the west gable of No.15, west to the end of the turning area.

Pembroke Dock

Admiralty Way

Both sides – from a point 4 metres south of the face of the dockyard wall, south for 10 metres.

Templeton

A478

West side – from a point 17 metres north of the centre of the junction with Poyers Grove, north for 15 metres.

Tenby

St Florence Parade

East side – from a point 26 metres north of the centre of the junction with South Cliff Street, north for 9 metres.

(b) Schedule 2.1 of the Order is amended as follows:–

Haverfordwest

Prendergast, for paragraph relating to west side, substitute:–

West side – a) from its junction with Bridgend Square roundabout north east to a point 35 metres south of the centre of Church Lane.

b) from a point 15 metres south of the centre of Church Lane, north east to its junction with the B4329 Cardigan Road.

Prendergast, east side, for paragraph relating to a), substitute:–

a)(i) from its junction with Cartlett Road, north to a point 8 metres south of the boundary of No.25/Hill Park Baptist Church.

a)(ii) from a point 2 metres north of the boundary of No.25/Hill Park Baptist Church, north to its junction with Back Lane.

St Mary's Street, for paragraph relating to south side, substitute:–

South side – From its junction with High Street, west for 30 metres.

Milford Haven

Fulke Street, west side, for paragraphs c) & d), substitute:–

c) from a point 23 metres south of the junction with Robert Street, south to a point 24 metres north of the junction with Charles Street.

d) from the junction with Charles Street north for 6 metres.

Milton Crescent, for paragraph relating to inner side, substitute:–

Inner side – a) from the junction with the east-west section of Milton Crescent, north for 12 metres.

b) from a point at the boundary of Nos 32/34, clockwise to the tangent point of the channel opposite number 25.

Milton Crescent, for paragraph relating to both sides, substitute:–

Outer side – from the junction with the east-west section of Milton Crescent, north to the boundary of Nos 69/71.

Shakespeare Avenue, north east side, for paragraph relating to a) substitute:–

a) from a point 10 metres south east of the centre of Central Court to a point 15 metres north west of that junction.

Pembroke

East Back, south side, delete paragraph b).

Tenby

Greenhill Avenue, west side, for paragraph relating to b), substitute:–

b) from its junction with Greenhill Road, south for a distance of 87 metres.

4) Amendment of Schedule 3

(a) In Schedule 3.5, insert:-

Haverfordwest

Prendergast

East side – from a point 8 metres south of the boundary of No.25/Hill Park Baptist Church, north for 10 metres.

(b) Schedule 3.10 of the Order is amended as follows:-

Milford Haven

Francis Street, for paragraphs relating to east side, substitute:-

East side – a) from a point 5 metres south of the junction with Charles Street southwards for a length of 23 metres.

b) from a point 10 metres north of the junction with Charles Street northwards for a distance of 17 metres.

c) from a point 31 metres north of the junction with Charles Street northwards for a distance of 8 metres.

Francis Street, west side, delete paragraphs b) & c).

Fulke Street, both sides, delete paragraph.

Robert Street, north side, delete paragraph f).

(c) In Schedule 3.14, insert:-

Narberth

High Street

East side – from a point 9 metres north of the junction with Market Square north for 20 metres.

5) Amendment of Schedule 4

(a) Schedule 4.9 of the Order is amended as follows:-

Milford Haven

Robert Street, north side, delete paragraph.

(b) Schedule 4.11 of the Order is amended as follows:-

Pembroke Dock

✕ **Argyle Street**, for paragraph relating to east side, substitute:-

East side – from a point 15 metres north of the junction with Bush Street, north for 13.2 metres.

6) Amendment of Schedule 5

(a) In Schedule 5.7, insert:-

High Street

East side – from a point 9 metres north of the junction with Market Square north for 20 metres.

7) Amendment of Schedule 6

(a) In Schedule 6.1, insert:-

Milford Haven

Fulke Street

West side – from a point 6 metres north of the junction with Charles Street north for 18 metres.

Tenby

Upper Park Road

South side – from a point 49 metres east of the centre of Edward Street, east for 24 metres.

8) Amendment of Schedule 8

(a) In Schedule 8.3, insert:-

8.3.8.20 The Croft –

East side – b) from a point 19 metres north of the boundary of Harbour Heights/ Richmond House northwards for 30 metres.

8) Revocations

Those lengths of road contained in “the Consolidation Order” including the schedules therein and subsequent variations are hereby revoked where specifically mentioned or where the amendment as contained in this Order provides a new definition of the restriction to apply to that section of highway.
