THE PEMBROKESHIRE COUNTY COUNCIL (OFF-STREET PARKING PLACES) (CONSOLIDATION) ORDER 2011 (VARIATION ORDER NO. 9A 2021)

Pembrokeshire County Council in exercise of its powers under Sections 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and as amended and the provisions of the Traffic Management Act 2004 and of all other enabling power of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order:-

This Order shall come into operation on the 17th December 2021 and may be cited as the Pembrokeshire County Council (Off-Street Parking Places) (Consolidation) Order 2011 (Variation Order No. 9A).

The Pembrokeshire County Council (Off-Street Parking Places) (Consolidation) Order 2011 which came into operation on the 1st day of February 2011 shall be varied so as to include the following:-

- 1. Revocation of The Pembrokeshire County Council (Off-Street Parking Places) (Consolidation) Order 2011 insofar as it relates to item number 21A, Cherry Grove car park, Haverfordwest, item number 21A, Rear of Dew Street car park (former Swimming Pool), Haverfordwest and item number 22, the Library/Community Education car park, Haverfordwest, which will have the effect of closing and removing the above car parks from the list of car parks.
- To amend the plans of car parking places numbered 13,15 and 71
- To create a car park in in Column 2 of the Schedule at car parking places number 15A
- To introduce a 2hr maximum stay in Column 7 of the Schedule at car parking place numbered 15A
