

PEMBROKESHIRE COUNTY COUNCIL

(PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2011 (VARIATION NO.20) ORDER 2021

The Pembrokeshire County Council ('the Council') in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46,49, 53, 101, 102, 124 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended, the provisions of the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers of the Act, and after consulting the Chief Officer of Police in accordance with Part IV of Schedule 9 to the 1984 Act hereby make the following Order:-

1. This Order shall come into operation on the 1st day of March 2021 and may be cited as the Pembrokeshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2011 (Variation No. 20) Order 2021.
2. The Pembrokeshire County Council (Prohibition and Restriction of Waiting, Loading and Parking Places) Consolidation Order 2011 ("the Consolidation Order") including the schedules contained therein and subsequent variations are hereby varied or amended as follows:-

1) Amendment of Schedule 2

(a) In Schedule 2.1, insert:-

Broad Haven

Marine Road

West side – from a point 9 metres north of the centre of the school vehicular access, south for 12 metres.

Fishguard

Clive Road

East side - (f) from the centre line of the junction of West Street car park exit road south for 10 metres.

Tower Hill

South side – from a point 143 metres east of the junction with Chapel Lane, eastwards for 10 metres.

Exit Road of West Street Car Park

Both sides – from the junction with Clive Road eastwards for 37 metres.

Goodwick

Main Street

East side – from the southern boundary of no 1 Goedwig Terrace, south for 20 metres

(b) In Schedule 2.1 of the Order is amended as follows:-

Cosheston

Point Lane, for paragraph relating to north side, substitute:

North side- From a point 15 metres west of the junction with Westhaven to a point 20 metres east of that junction.

Fishguard

Access Road to West Street Car Park, for paragraph relating to

both sides - From the junction with Clive Road eastwards for 10 metres is withdrawn

Saundersfoot

The Glen, for paragraph relating to both sides, substitute:

East side – from its junction with the B4316 in a south east then south west direction for the full length

West side – i) from its junction with the B4316 in a south east then south west direction to a point 46 metres south east then south west of the boundary of property Glenvale.

ii) from a point 66 metres south east then south west of the boundary of property Glenvale south west for 30 metres.

(c) In Schedule 2.8, insert

Saundersfoot

The Glen

West side – from a point 46 metres south east then south west of the boundary of Glenvale, south west for 20 metres

2. Amendment to Schedule 3

Schedule 3.10 is amended as follows:-

Haverfordwest

Cartlett

South side, the paragraph relating to southside (b) is withdrawn.

3. Amendment to Schedule 8

In Schedule 8.5, insert:-

Haverfordwest

Cartlett

South side, from a point 57 metres east of its westernmost junction with the A40 in an easterly direction for 20 metres.

4) Revocations

Those lengths of road contained in "the Consolidation Order" including the schedules therein and subsequent variations are hereby revoked where specifically mentioned or where the amendment as contained in this Order provides a new definition of the restriction to apply to that section of highway.
