

**THE COUNCIL OF THE CITY OF PETERBOROUGH**  
**WESTGATE PEDESTRIAN AND CYCLE ZONE ORDER 2024**

Notice is hereby given that The Council of the City of Peterborough has made an Order in exercise of its powers under Sections 1, 2 and 4 and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984, 'the Act of 1984', following consultation with the Chief Officer of the Police and all other enabling powers.

1. This Order shall come into operation on the 16<sup>th</sup> May 2024 and may be cited as "The Council of Peterborough, Westgate Pedestrian and Cycle Zone Order 2024" ("the Order") . and shall replace The Council of Peterborough, Westgate Pedestrian and Cycle Zone Order 2023
2. The Order makes Westgate as lies between its junctions with Broadway and Park Road a pedestrian and cycle zone ("the Pedestrian and Cycle Zone") as detailed in this Order and as shown on the attached Plan in the Schedule
3. The Pedestrian and Cycle Zone shall operate at all times
4. No motorised vehicle shall enter the Pedestrian and Cycle Zone at any time whether ridden driven wheeled pushed or propelled in any other way save for the exemptions specified in paragraphs 6, 7, 8 and 10 of this Order
5. No waiting is permitted at any time
6. Loading by goods vehicles within the designated loading bays for a maximum period of 30mins is permitted as follows:
  - Between Midnight and 10.30hrs
  - Between 16.30hrs and Midnight
7. Permit Holders are permitted to wait within the designated loading bays between 10.30 hours and 16:30 hours.
8. Exemptions
  - a) The following vehicles are exempted when undertaking or discharging statutory powers or duties,
    - i. Emergency service vehicles,
    - ii. Council service vehicles,
    - iii. Highway maintenance vehicles,
    - iv. Statutory undertaker vehicles.
  - b) Buses
  - c) Hackney carriage and private hire vehicles
  - d) Vehicles that possess a valid permit issued by the City Council
  - e) Vehicles that have been granted an exemption by the Council prior to entering the above road.
9. No person shall cause any vehicle proceeding in Park Road to make a left turn into Westgate, except for pedal cycles
10. No person shall cause any vehicle proceeding in Westgate to the west of its junction with Park Road to enter Westgate, except for buses and pedal cycles

11. All existing Traffic Regulation Orders are hereby revoked insofar as they are inconsistent with the terms of this Order

12. The Interpretation Act 1978 shall apply for the Interpretation of this Order as it applies for the interpretation of an Act of Parliament.

### Definitions

“Council Service Vehicle” – A vehicle owned or leased by the Council that is used in the undertaking of the Council's business

“Goods” includes postal packets of any description and ‘delivering’ and ‘collecting’ in relation to any Goods includes checking the Goods for the purpose of their delivery or collection;

“Goods Vehicle” – a vehicle primarily used for the transportation of Goods

“Vehicle” means a Motor Vehicle, Motorcycle, Moped or Electric Vehicle;

“Waiting” refers to a Vehicle stopping and remaining stationary for any period of time whether or not with the intention of parking and whether or not the Driver is in the Vehicle


