### ROAD TRAFFIC REGULATION ACT 1984

# THE CITY OF PLYMOUTH (OFF-STREET PARKING PLACES) AMENDMENT ORDER (NUMBER 2), 1990

The Plymouth City Council in exercise of their powers under Part IV and Schedule 9 of the Road Traffic Regulation Act, 1984, (hereinafter referred to as "The 1984 Act" and of all other powers enabling them in that behalf after consultation with the Chief Constable of the Devon and Cornwall Constabulary in accordance with the said Schedule 9 of the 1984 Act HEREBY MAKE THE FOLLOWING ORDER:—

## Commencement and Citation

1. This Order shall come into operation on the day of December 1990 and may be cited as "The City of Plymouth (Off-Street Parking Places) Amendment Order (Number 2) 1990"

#### Interpretation

- 2. In this Order, except where the context otherwise requires, the expression "The Principal Order" means "The City of Plymouth (Off-Street Parking Places)
  Order 1988"
- 3. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of Acts of Parliament.

  Amendment of the Principal Order
- 4. The Principal Order shall be read as though the Second Schedule thereof incorporated the matters set out in the Schedule hereto for the periods therein specified and those matters set out in the Second Schedule of the Principal Order relating to Leigham Street car park were deleted
