- 2. In this Order, except where the context otherwise requires, the expression "The Principal Order" means the City of Plymouth (Off Street Parking Places) Order 1988"
- 3. In this Order except where the context otherwise requires the expression "the first Amendment Order" means The City of Plymouth (Off Street Parking Places) Amendment Order (number 1) 1989

Amendment of the Principal Order

4. The Principal Order as amended by the first Amendment Order shall read as though article 21 incorporated the matters set out in the first schedule hereto and as though the second schedule thereof incorporated the matters set out in the Second Schedule hereto and that the matters set out in the Second Schedule of the Principal Order as amended by the first Amendment Order relating to Morice Street Car Park and Lipson Road/Regent Street Car Park were deleted.


