

**THE CITY OF PLYMOUTH (OFF STREET PARKING PLACES)
(ECLIPSE PARKING CHARGE)
AMENDMENT ORDER (NO 16)**

1. The Council of the City of Plymouth (hereinafter referred to as the Council) in exercise of its powers under Section 35, Part III and Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the 1984 Act) and all other powers enabling them in that behalf and following consultations in accordance with Schedule 9 of the 1996 Act and the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 HEREBY MAKE THE FOLLOWING ORDER

COMMENCEMENT AND CITATION

2. This Order shall come in to operation on 12th day of July 1999 and shall be cited as The City of Plymouth (Off Street Parking Places) (Eclipse Parking Charge) Amendment Order (Number 16).

INTERPRETATION

3. In this Order except where the context otherwise requires the expression "The Principal Order" means The City of Plymouth (Off Street Parking Places) Order 1988 as amended by The City of Plymouth (Off Street Parking Places) Amendment Orders (Nos. 1 - 13).
4. "The Western Approach Order" means The City of Plymouth (Off-Street Parking Places) (Western Approach Car Park) Order 1994 as amended by The City of Plymouth (Off Street Parking Places) (Western Approach Car Park) Amendment Order (No. 1) 1995 and as amended by The City of Plymouth (Off Street Parking Places) Amendment Orders (Nos. 11-13).
5. The Interpretation Act 1978 shall apply to the interpretation of this order as it applies to the interpretation of Acts of Parliament.

AMENDMENTS

6. The Principal Order shall be read as though the fourth, fifth, sixth and seventh columns of the Second Schedule incorporated the amendments as set out in the Schedule which follows in respect of the Car Parks referred to.
7. The Western Approach Order shall be read as though the scale of charges in Schedule 1 incorporated the amendments as relate to the Western Approach Car Park contained in the Schedule which follows.
