THE CITY OF PLYMOUTH (OFF STREET PARKING PLACES)

(TEMPORARY RE-LOCATION OF BRETONSIDE CAR PARK) ORDER 1996

1. The Council of the City of Plymouth (hereinafter referred to as "the Council") in exercise of its powers under Section 33(2) and 35, Part IV and Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the 1984 Act) and all other enduring powers in that behalf and with the consent of Devon County Council in accordance with Section 39(3) of the 1984 Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the 1984 Act and in accordance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1989,

HEREBY MAKES AN ORDER IN THE FOLLOWING TERMS :-

COMMENCEMENT AND CITATION

2. This Order shall come into operation on the Second day of September 1996 and shall be cited as "The City of Plymouth (Off-Street Parking Places) (Temporary Re-location of Bretonside Car Park) Order 1996.

INTERPRETATION

3. In this Order where the conditions within the existing Parking Order, being The City of Plymouth (Off-Street Parking Places) Order 1988 (the Principal Order) as amended by the City of Plymouth (Off-Street Parking Places) Amendment Order (No's 1-10) are inconsistent the same conditions therein will apply.

4. The interpretation Act of 1978 or any statutory re-amendment thereof shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

AFFECT OF THIS ORDER

5. The short term car park facility situated at and being known as Bretonside car park is temporarily closed and two replacement parking facilities to temporarily replace the Bretonside short term car park are situated adjacent to the Bretonside car park, the location of the replacement car parks being shown edged red on the plan annexed hereto for identification purposes only. One car park indicated 'A' will be for private permit only parking plus motorcycles. Car park 'B' will be for Pay & Display the charges levied in car park 'B' being 25 pence for up to 30 minutes stay and 40 pence for 1 hour maximum stay.
6. In all other respects the existing Principal Order as amended by The Council of the City of Plymouth (Off Street Parking Places) Amendment Order (No.'s 1-10 inclusive) shall remain in full force and effect and the same conditions and charges therein in so far as they relate to the short term Bretonside car park shall apply to the Order herein.
