THE CITY OF PLYMOUTH (TRAFFIC REGULATION AND STREET PARKING PLACES) (AMENDMENT No 2004.05 – BARNE BARTON) ORDER 2004

The City of Plymouth in exercise of their powers under the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act of 1984, hereby make the following Order:

This Order may be cited as The City Of Plymouth (Traffic Regulation And Street Parking Places) (Amendment No 2004.05 – Barne Barton) Order 2004 and shall come into operation on the **5**th **day of July 2004.**

This Order amends The City of Plymouth (Traffic Regulation and Street Parking Places) Consolidation Order 2004 as follows:

In the Articles of this Order the following items be added:

- 1. That the following be added to Article 14 in the correct numerical sequence
- PART 15 between the hours of 8am and 6.30pm on Mondays to Saturdays in any of the lengths of restricted road specified in Part 15 of the Ninth Schedule to this Order;
- 2. That the following be added to Article 35 in the correct numerical sequence

PART 74 -

- a) waiting limited to 30 minutes between the hours 10am and 5pm Mondays to Saturdays.
- b) Where a vehicle has been left in a designated parking place described in Part 74 of the Third Schedule to this Order and that vehicle is subsequently moved that vehicle is not permitted to return to that parking place until a period of 7 hours has elapsed otherwise a penalty charge shall be payable in accordance with Part J to this Order.
- 3. That Article 15 be deleted and replaced with

Failure to comply with the provisions outlined in parts A to G inclusive and part I of this Order shall result in the owner of that vehicle being liable to a Penalty Charge in accordance with Part J of this Order

- 4. That Article 60 (Part H, Exemptions, Disabled Persons Vehicles) be deleted and replaced with Unless otherwise stated in the title of the relevant Schedules to this Order, nothing in this Order shall render it unlawful to cause or permit a disabled persons vehicle which displays in the relevant position a disabled persons badge and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the roads, lengths of road or sides of road referred to *in part B or in any Residents Parking Bay (unless otherwise specified in Schedule Eight Permit Parking Places)to* this Order for a period not exceeding 3 hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in that length of road).
- 5. That the following restriction types be added in the appropriate sequence

ONE WAY

Save specific classifications of vehicles as shown in the Two Hundred and First Schedule and as provided in part H to this Order no person shall cause or permit any vehicle to proceed in any of the roads specified for the lengths specified other than in the direction specified in the Two Hundred and First schedule to this Order.

PROHIBITION OF DRIVING

Save as provided in part H to this Order no person shall cause or permit any vehicle to proceed in any road specified for that length specified in the various parts to the Two Hundred and Second Schedule to this Order as defined below.

- PART 1 **Prohibition Of Driving of all Vehicles** in any length of road specified in Part 1 of the Two Hundred and Second Schedule to this Order;
- PART 2 Prohibition Of Driving of all Vehicles (With Specific Exemptions as detailed in brackets in the description in the Schedule) in any length of road specified in Part 2 of the Two Hundred and Second Schedule to this Order;
- PART 3 **Prohibition Of Driving of all Vehicles Except for Access** in any length of road specified in Part 3 of the Two Hundred and Second Schedule to this Order;
- PART 4 **Prohibition Of Driving of all Vehicles Except for Buses and Taxis** in any length of road specified in Part 4 of the Two Hundred and Second Schedule to this Order;

PROHIBITED TURNS

Save specific classifications of vehicles as shown in the Two Hundred and First Schedule and as provided in part H to this Order no person shall cause or permit any vehicle proceeding in the roads specified in Column 1 of the following parts of the Two Hundred and Third Schedule to this Order to make the turn specified in the following parts into the road specified in column 2 of that schedule.

- PART 1 **No Right Turn** from any road specified to any road specified in Part 1 of the Two Hundred and Third Schedule to this Order:
- PART 2 **No Left Turn** from any road specified to any road specified in Part 2 of the Two Hundred and Third Schedule to this Order;
- PART 3 **No 'U' Turn** from any road specified to any road specified in Part 3 of the Two Hundred and Third Schedule to this Order;

SPEED LIMIT

Save as provided in part H to this Order no person shall cause or permit any vehicle to exceed the speed specified on any road specified in the various parts to the Two Hundred and Fifth Schedule of this Order as defined below.

- PART 1 **De-Restriction** in any length of road specified in Part 1 of the Two Hundred and Fifth Schedule to this Order;
- PART 2 **20 MPH Maximum Speed Limit** in any length of road specified in Part 2 of the Two Hundred and Fifth Schedule to this Order;
- PART 3 **30 MPH Maximum Speed Limit** in any length of road specified in Part 3 of the Two Hundred and Fifth Schedule to this Order;
- PART 4 **40 MPH Maximum Speed Limit** in any length of road specified in Part 4 of the Two Hundred and Fifth Schedule to this Order;
- PART 5 **50 MPH Maximum Speed Limit** in any length of road specified in Part 5 of the Two Hundred and Fifth Schedule to this Order;

WEIGHT RESTRICTIONS

Save as provided in part H to this Order no person shall cause or permit any vehicle to proceed in the roads specified for the length specified, if the maximum gross weight of that vehicle exceeds that specified in the various parts of the Seventh Schedule to this Order as defined below.

- PART 1 **Maximum Gross Weight 7.5 Tonnes** in any length of road specified in Part 1 of the Two Hundred and Eighth Schedule to this Order;
- PART 2 Maximum Gross Weight 7.5 Tonnes Except for Access in any length of road specified in Part 2 of the Two Hundred and Eighth Schedule to this Order;
- PART 3 **Maximum Gross Weight 18 Tonnes** in any length of road specified in Part 3 of the Two Hundred and Eighth Schedule to this Order;
