

The City of Plymouth
(Traffic Regulation and Street Parking Places)
(Amendment No. 2004.25a – Kirkby Place Area, Mary Dean
Avenue and Mayflower House Court Car Park)
Order 2004

The City of Plymouth in exercise of their powers under the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Schedule 9 to the Act of 1984, hereby make the following Order:

The City of Plymouth (Traffic Regulation and Street Parking Places) (Amendment No. 2004.25a – Kirkby Place Area, Mary Dean Avenue and Mayflower House Court Car Park) Order 2004.

This shall have the affect to amend “The City of Plymouth (Traffic Regulation and Street Parking Places)(Consolidation) Order 2004 as follows:

1) In the Articles to this Order

a) To add the following to Article 35 in Part G (Designation and use of Parking Places) in the correct numerical sequence:

PART 76 a) waiting limited to **30 minutes between the hours 8am and 6pm Mondays to Saturdays.**

b) Where a vehicle has been left in a designated parking place described in Part 76 of the Third Schedule to this Order and that vehicle is subsequently moved that vehicle is not permitted to return to that parking place until a period of **90 minutes** has elapsed otherwise a penalty charge shall be payable in accordance with Part J to this Order, (see Articles 54 & 55 for exemptions).

b) To add the following to Article 46 in Part G (Designation and use of Parking Places) in the correct numerical sequence:

PART 6 those lengths of road specified in Part 6 are goods loading bays **at any time** with an exemption for certain vehicles (as detailed in brackets) to wait in the loading bays.

c) To add 76 in the correct numerical sequence in Article 54 and 55 in PART H Exemptions, Permit and Visitor Ticket Holders, Limited Waiting.

2) The following items be added to the specified Schedules in the correct alphabetical Order:

Schedule No. 1.10 (No Waiting At Any Time)

Kirkby Place	North side from its junction with James Street eastwards for a distance of 17 metres. South side from its junction with Portland Square Lane North eastwards for a distance of 11 metres.
Mary Dean Avenue	East side from a point 4.5 metres from the northern extent (at the school gates) southwards for a distance of 18 metres (inclusive of the access to the garages).
Mary Dean Avenue	West side from its northern extent (at the school gates) southwards for a distance of 9 metres and eastwards for a distance of 4 metres.
Mary Dean Avenue	West and North side from a point 18 metres from the northern extent (at the school gates) southwards and westwards for a distance of 64 metres. (Restriction applies to the area between the centre of the road and roadmarking to diag. No. 1040.4, where roadmarking to diag. no. 1040.4 does not exist, restriction applies to the area between the centre of the road and the highway boundary).
Mayflower House Court Car Park	All sides for their entire length.

Schedule No. 3.76 (Limited Waiting to 30 minutes no return for 90 minutes, Mon-Sat, 8am-6pm Exemption for Permit and Ticket Holders)

Endsleigh Place	West side from a point 5 metres north of the junction with Portland Square Lane North to a point 36 metres south of the junction with Endsleigh Place Ope.

Schedule No. 6.06 (Goods Loading Bay At Any Time with an exemption for those vehicles in brackets)

Kirkby Place	North side from a point 26 metres east of its junction with James Street eastwards for a distance of 61 metres. (University Post Office Vehicles). South side from a point 11 metres east of its junction with Portland Square Lane North eastwards for a distance of 9 metres. (University Post Office Vehicles).

Schedule No. 8.03 (Permit Parking Mon-Sat 9am-7pm)

Kirkby Place North side from a point 17 metres east of its junction with James Street eastwards for a distance of 9 metres.

Schedule No. 8.08 (Permit Parking Mon.-Sat. 10am-5pm).

Portland Square Lane North the north side from a point 10 metres west of its junction with Endsleigh Place for a distance of 22 metres.

Schedule No. 9.01 (No Loading/Unloading at any Time)

Kirkby Place North side from its junction with James Street eastwards for a distance of 17 metres.
South side from its junction with Portland Square Lane North eastwards for a distance of 11 metres.

3) The following items be revoked from the specified Schedules in the correct alphabetical Order:

Schedule No. 1.10 (No Waiting At Any Time)

Kirkby Place The north side from the junction with James Street for 9 metres.
The north side from a point 21 metres east of the junction with James Street for a distance of 7 metres in an easterly direction.
The north side from a point 48 metres east of the junction with James Street for a distance of 6 metres in an easterly direction.
The north side from a point 63 metres east of the junction with James Street for a distance of 5 metres in an easterly direction.
The south side from the junction with Portland Square Lane North for a distance of 4 metres.

Schedule No. 4.12 (Pay and Display Maximum Stay 4 hours no return within 1 hour Mon.-Sat. 10am-5pm Visitor Ticket Holders are Exempt)

Kirkby Place

- (i) the north-west side from a point 10 metres north east of the junction with James Street for a distance of 12 metres in a north easterly direction

Schedule No. 8.03 **(Permit Parking Monday to Saturday 9am to 7pm)**

Kirkby Place

- (i) *the north-west side from a point 33 metres north-east of the junction with James Place for a distance of 19 metres*
- (ii) *the north-west side from a point 58 metres north east of the junction with James Place for a distance of 9 metres in a north easterly direction*
- (iii) *the north-west side from a point 72 metres north east of the junction with James Place for a distance of 19 metres in a north easterly direction*

Schedule No. 8.08 **(Permit Parking Mon.-Sat. 10am-5pm).**

Endsleigh Place

- (i) *the west side from a point 5 metres north of the junction with Portland Square North to a point 36 metres south of the junction with Endsleigh Place Ope*

Portland Square Lane North

- (i) *the north side from a point 10 metres west of its junction with Endsleigh Place to its junction with Kirkby Place*

Schedule No. 6.05 **(Goods Loading Bays Mon.-Fri. 9am-6pm)**

Kirkby Place

the south east side from a point 14 metres east of its junction with James Street for a distance of 14 metres in a north easterly direction.

This Order shall come into force on the 8th December, 2004 and may be cited as The City of Plymouth (Traffic Regulation and Street Parking Places) (Amendment No. 2004.25a – Kirkby Place Area, Mary Dean Avenue and Mayflower House Court Car Park) Order 2004”.
